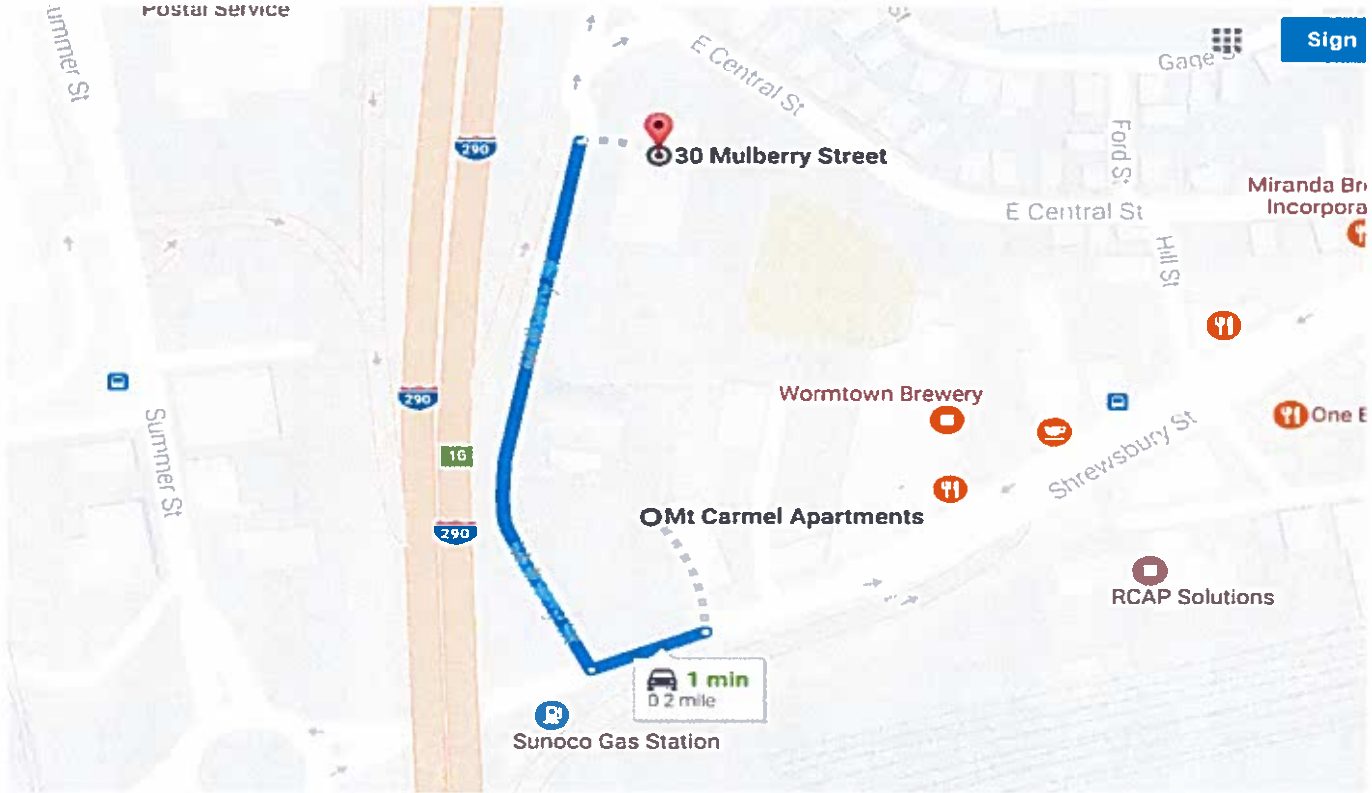

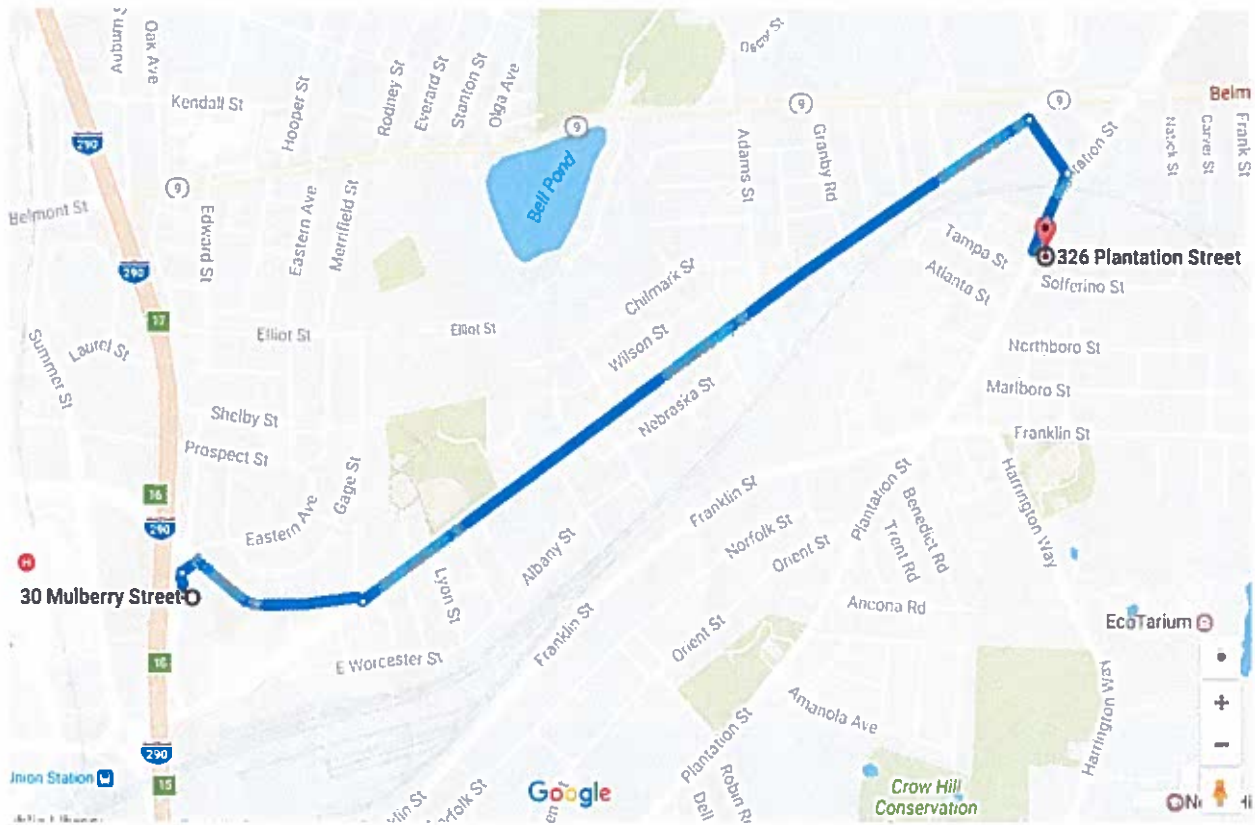

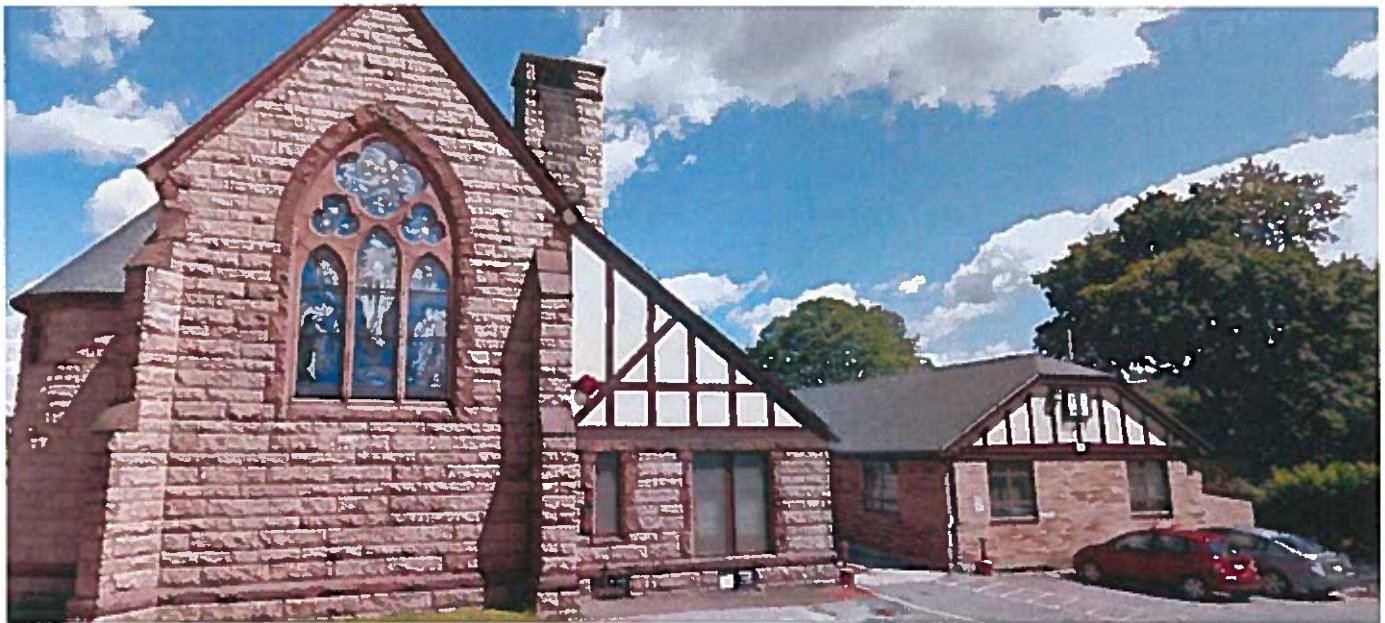
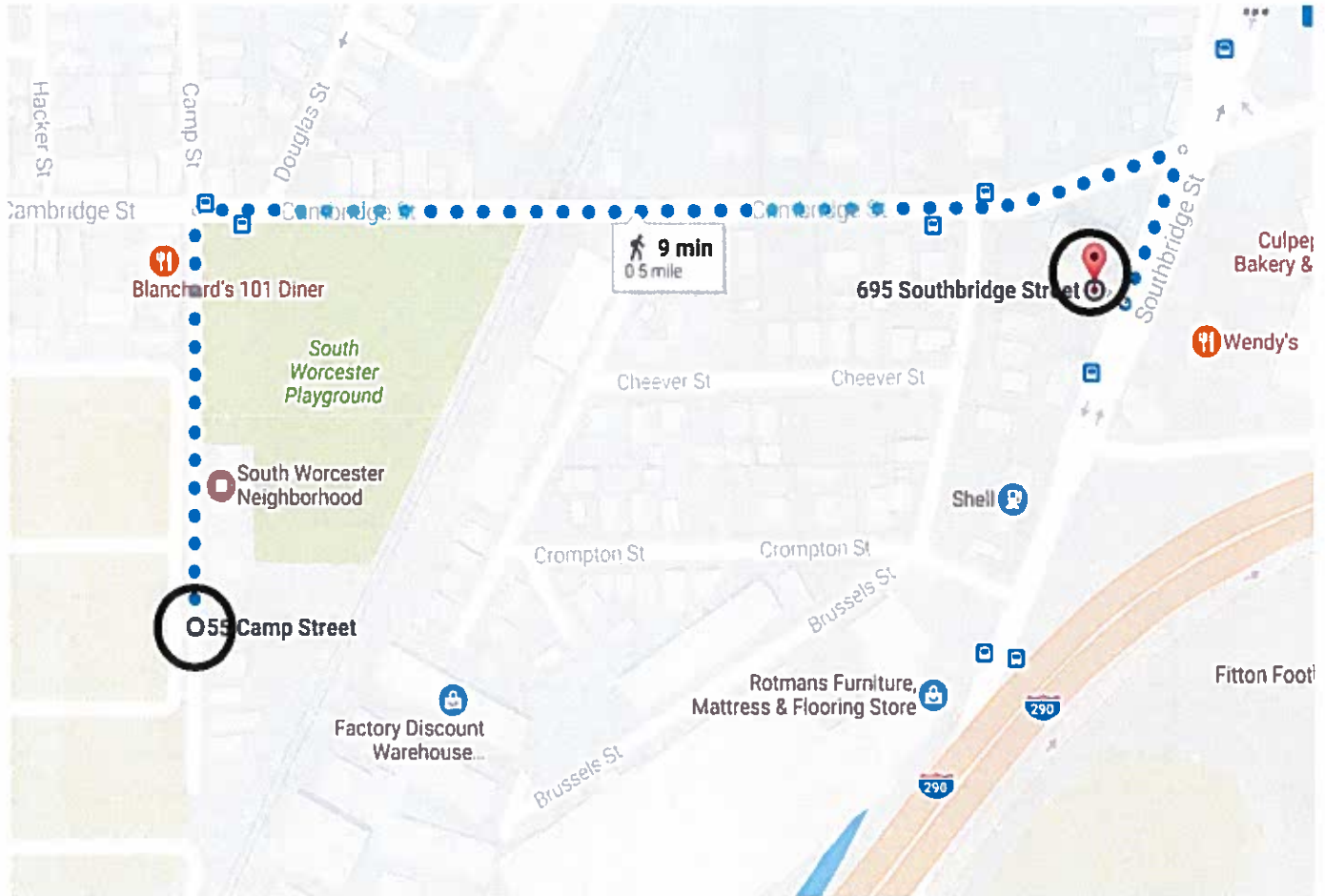


Voting Location
