





RE: Update concerning the 2020 re-districting process

The purpose of this memo is to provide you an update concerning the 2020 re-districting efforts. On Wednesday, October 27, 2021 the Local Election Districts Review Commission voted unanimously to approve the City of Worcester 2020 redistrict map.

With the LEDRC approval, the City Clerk's office will begin the process of assigning new Ward and Precincts to Worcester voters in the voter registration database. With the 2020 redistricting map, Worcester has 60 precincts for Municipal Elections and 62 precincts in State Elections. State elections will consist of two split precincts Wards 7-5 and 4-2. Voters in 7-5 A will vote in the 6th State Senate district and Voters in 7-5 B will vote in 8th State Senate district. Voters in 4-2 A will vote in the 9th State Senate district and Voters in 4-2 B will vote in 8th State Senate district.

I am extremely grateful for the assistance of the Senate and House Redistricting Chairs Senator William N. Brownsberger and Representative Michael J. Moran during the 2020 redistricting process. With their assistance, Worcester was able to minimize the effect of split precincts and voter confusion for the next 10 years.

RE: Defining Split Precincts in Election Operations

The purpose of this memo is to provide you information concerning existing split precincts in the commonwealth and the effect split precincts have in election operations.

Several Massachusetts communities span multiple state House or state Senate districts, but in almost all of those cases, they are divided along local ward or precinct lines. To my knowledge, only one precinct in Massachusetts is subdivided into two state legislative districts, in Boston, Ward 5 Precinct 2 falls into the Ninth Suffolk House district, while Ward 5 Precinct 2A is in the Seventh Suffolk House district. Eight other municipalities Palmer, Bellingham, Winchendon, Fall River, Raynham, Cambridge, Sudbury and Andover have sub precincts for congressional districts.

Defining Split Precincts

Precincts are usually the smallest unit of organization for an election district. The split precinct is the exception to this rule. A split precinct is one in which some of the voters in the precinct vote in one election district and other voters vote for the same type of office, but in a different district. For example, suppose the State Senate Redistrict committee drew the boundary between the 68th and 69th Senate districts straight through the middle of the local election precinct XYZ (figure 1 below). In

this case, even though everyone is voting in the same precinct, the voters to the left of the State Senate district line would receive a ballot with the candidates for the 68th district seat. The voters to the right of the State Senate district line would receive a ballot with the candidates for the 69th district seat.



Split precincts can cause voter confusion on Election Day and at the polls and can even result in some voters receiving the wrong ballot. If that occurs and the election is close, it could be cause for a contested election and even lawsuit challenging the validity of the election.

A Sample Split Precinct

Here is a hypothetical split precinct situation:

The West Precinct is now a split precinct. Of its 2,000 voters in the precinct, 1,500 reside in the 1st State Senate district and 500 reside in the 2nd State Senate district. There is, of course, only one polling place.

Election Day Polling Location Operations

Split precincts need to be operated on Election Day as if they were "two separate precincts. This will increase cost of polling place set-up, voter education, the number of voting machines, electronic poll pads, number of election officials, police officers, equipment set up staff, ballot types and supplies. Currently the city of Worcester has 50 polling locations and with the 2020 redistricting, we are going to increase to 62 precincts in state elections. Two of the precincts will be split due to the State Senate Districts.

Treating the precinct segments as "separate" precincts has significant advantages:

- It is easier to keep the voters and ballots for the different districts apart and, thus, avoid voters getting the wrong ballot.
- It simplifies programming voting equipment if a machine is dedicated to a single ballot type rather than multiple ballots styles and training officers of election to call up the correct ballot for each voter.





- Electronic pollbooks for each precinct segment can be linked together so you can get a pollbook count for each precinct segment at the polling place on Election Day.
- It is easier for election officers to understand how to run the precinct.

Election Day Polling Location Operations

For a split precinct, the layout and staffing of the polling place are of prime concern. If people can visualize the facility as two polling places, then half the battle is won. (If the precinct is split three or four ways, it can be visualized as three or four separate polling places.)

One of the concerns in the City of Worcester election operations is space in the current voting locations, to operate split precincts we need to set up multiple voting areas.



Election Administration Concerns

Voter confusion and disenfranchisement is the biggest concern. If a city or town has different voting precincts for local and state elections, they will need to notify voters of the correct locations before each and every election. Even then, some voters may go to the wrong location and rather than go to the redirected location, may choose not to vote. When precincts are split, if they do share a polling place, there is a likelihood that voters could be given the wrong ballot style.

Under the Hybrid System, the Worcester School Committee shall be comprised of seven (7) single-member district based seats, including two (2) majority-minority districts, based on citizen voting age population of Hispanic/Latino/a and Black residents, with one (1) at-large seat and the Mayor as chair.

Option #3: A hybrid system that combines single-member district-based seats with 2 at-large seats. Under the Hybrid System, the Worcester School Committee shall be comprised of six (6) single-member district-based seats, including two (2) majority-minority districts, based on citizen voting age population of Hispanic/Latino/a and Black residents, with two (2) at-large seats and the Mayor as chair.
