Commissioner Shea called the meeting to order at 10:00 a.m.

Approval of the Minutes:

Upon a motion by Commissioner Mullan the Commission voted 3-0 to approve the minutes of August 16, 2012.

Unfinished Business

935 Grafton Street – Ervin Kasmi- Plaza Liquors

Petition: Request for change of manager

Ervin Kasmi appeared on behalf of application. Mr. Kasmi stated he has been working at store for a few months and has been appointed to be the new manager.
