Lt. Johnson presented the following:

On August 30, 2018, Officer Patrick Harrington along with members of the Alcohol Enforcement Unit, WPI Police, Fire & Code Prevention Units were conducting compliance and went to Beatnik's at 433 Park Avenue.

Fire Department investigators asked the doorman how many were inside Beatanik's and the doorman stated that he was not sure. The occupancy of the inside of the business is 97. Fire Department investigators conducted an occupancy count and confirmed there were over 200 patrons inside.

During the Fire Department compliance check police investigators began checking identifications of patrons and found four different patrons under the age of 21 with fake identifications consuming alcoholic beverages.

Mr. Ford stated that the violation had occurred a week after he started operating the premises. After the violation he stopped taking out of state IDs, and now mans the front door himself, checking the IDs, and has another employee at back to prevent people coming in through the emergency exit.

Upon a motion the Commission voted 2-0 that that Rules #7, #14, #27 did occur.

Upon a motion the Commission voted 2-0 to impose a one day suspended suspension.
