Violation Hearings

13. Mercado Garcia Enterprises, Inc., 65 James Street

• Cessation of Business hearing

Attorney Wayne LeBlanc and Dioanne Mercado called in for the meeting.

Mr. LeBlanc stated that he has a client who is looking to transfer the current license to South Ludlow Street but the South Ludlow Street location needs a special permit from the Zoning Board of Appeals for the use. He intends to file that for the January 2021 Zoning meeting.

Upon a roll call the Commission voted 3-0 to postpone the item to the February 4, 2021.

14. Habaibna Hoookah Lounge, 250 Commercial Street

• Violation of Rules # #14, #37, 204 C.M.R. 4.00

Anhar Kaaed called in for meeting and waived right counsel.

Sgt. Needham presented the following;

On February 28, 2020, Officers Patrick Harrington and Officer Glen Stout responded to Habaibna Hookah Lounge to assist Worcester Police operations officers with an incident involving 10-12 people inside the Licensed Premises fighting and breaking windows.

Upon arrival, Officer Stout was unable to see inside the premises due the windows being covered. Upon entering, he spoke with Officer Andrei Cimpan who stated that the parties involved in the altercation were gone.

The officers observed a pool table on its side and one of the front windows was broken and also observed posters advertising drink packages.

Mr. Kaeed stated that other businesses in Worcester have tinted windows but after the officer told them to take the tint off they did.

Mr. Kaeed stated that with regards to the poster, they were keeping the bottles behind the bar and then would serve the seated customers and didn't realize they could not advertise drink packages. He apologized as they were just promoting the bar.

Lt. Johnson stated that they have had few issues with the establishment.

Mr. Kaaed stated that when the fight broke out security tried to move people out and people tried to push security so they called WPD for assistance.

Sgt. Needham stated that WPD recently stopped at the establishment. When things are better the establishment would like to get a police detail to supplement their security detail.

Commissioner Haller stated that this comes across as poor management on behalf of the owners.

The Commission noted that there was one previous violation on the record for the establishment.

Upon a roll the Commission voted 3-0 that the violation did occur.

Upon a roll the Commission voted 2-1 (Commissioner Haller voting against) to issue a one day suspended suspension.

15. Swamishriji Corp dba Boston Liquor Mart, 566 Southwest Cutoff

• Violation of Rules #6, #21 and 204 CMR 2.05

Attorney Matthew Porter & Jignesh Patel called in for the meeting.

Sgt. Needham read the following report;

On January 26, 2020, Officers of the Worcester Police Department Alcohol Unit conducted compliance checks at various package stores throughout the city of Worcester. An underage male accompanied the officers and was instructed to enter a package store and attempt to purchase alcohol without providing identification.

At around 12:55 p.m. the underage male entered Boston Liquors and purchased a six pack of Bud Light 12 oz. bottles. The male was able to purchase the alcohol without being asked for identification.

Attorney Porter stated that the violation did occur. Management has been all recertified under TIPS and they will also be willing to take the WPD training course reviewing the rules.

Upon a roll call the Commission voted 3-0 that the violation did occur.

Upon a roll call the Commission voted 3-0 to issue a Warning.

17. Modification of Entertainment and On-premises Liquor License Renewal Fees for Calendar Year 2021

Commissioner Walter Shea reviewed the reduced fees for year 2021.

- Renewal fees for on-premises licenses are reduced by 50 percent for calendar year 2021 only (see Table 1);
- Renewal fees for entertainment licenses are waived for calendar year 2021 only;
- On-premises establishments that are closed may defer payment of their 2021 license renewal fees for up to 90 days; and
- Fees for all new licenses and for off-premise licenses are unchanged from 2020.
