#### **Violation Hearings**

## 15. Paku Paku, Inc., 215 Chandler Street

• Violations of Rules #11, #14, #17

Attorney Leonardo Anguilo and Ligia Mustafa appeared in person for the violation hearing.

Sergeant Needham presented the following;

On May 8, 2021 Worcester Police were notified via shot spotter activation of possible gun fire in the area of 219 Chandler Street and when officers responded to the area they observed a large crowd outside the Paku Lounge and people running in different directions away from the premises. Worcester Police located a male gunshot victim lying on the ground across the street and the victim was transported to the hospital.

On May 8, 2021, Officer Patrick Harrington who is assigned to the Alcohol Enforcement Unit conducted an investigation for violations that occurred at the Paku Lounge located at 215 Chandler Street. Upon reviewing the video surveillance the following was observed:

- Wait staff from the Paku Lounge delivering (2) 750 ml of Hennessy bottled alcohol to patrons in the V.I.P. area of the premises
- Wait staff from the Paku Lounge delivering (1) 750 ml bottle of Silver Patron Tequila to patrons;
- Patrons binge drinking directly out of the large bottles of champagne;
- A patron using vape e-cigarette inside the premises;
- Two (2) patrons coming and going out the side door onto the public sidewalk with alcoholic beverages poured from the bottle service; and,
- Security staff monitoring the area and allowing the violations to occur.

Mr. Anguilo stated that Ms. Mustafa was not disputing the facts as presented.

Ms. Mustafa stated that she was not there that evening and her partner was there that evening.

Ms. Mustafa stated that they use a wand at the door to check patrons and stated that she has children so it hard for her to be there every evening, and she's looking to do a change of manager and put her partner on the license.

Chairman Shea stated that there seems to be no control of the premises which is not good.

Sgt. Needham stated that most of the issues seem to be happening at night and Ms.Mustafa is mainly there during the day.

Upon a roll call vote the Commission voted 3-0 that the violation did occur.

Chairman Shea stated that these are serious violations.

The Commission noted that there was a previous on violation file.

Upon a roll call vote the Commission voted 3-0 to impose a ten day suspension with five days to be suspended and five days to be served August 6, 7, 13, 14, 20, 2021.

On May 1, 2021, Officers of the Worcester Police Department Alcohol Unit conducted compliance checks at various package stores throughout the city of Worcester. An underage male accompanied the officers and was instructed to enter a package store and attempt to purchase alcohol without providing identification.

At around 11:34 a.m. the underage male entered Austin Liquors and purchased a six pack of Bud Light cans. The male was able to purchase the alcohol without being asked for identification.

Members of the Alcohol Unit notified the store manager of the violation.

Mr. Porter stated that they are not disputing the facts as presented.

Mr. Porter stated that all employees are TIPS certified and they have a scanner and this was a lapse in judgement by a clerk. They will continue to train staff, and no matter the age of the customers, all customers will have their ID's checked.

Mr. Porter stated that the clerk involved in the incident was terminated.

Commissioner Haller stated she had concern that this was second violation within a year.

Upon a roll call vote the Commission voted 3-0 that the violation did occur.

Upon a roll call vote the Commission voted 3-0 to impose a one day suspended suspension.

Mr. Denapoli stated that they are very upset that this has happened and there has been a change of manager after this incident occurred, and they have updated their system so anytime liquor is sold there must be a scan of the product.
