# 17. Exchange Place, Inc., dba Michael's Cigar Bar, 1 Exchange Place

O Violations of Rules #1, #14, #29-Hours, disturbance of the peace

Attorney Robert Hennigan and Mark Esperti, the manager of record, appeared upon behalf the violation.

Sgt. Needham presented the following:

On June 20, 2022, Officer James Ciru of the Worcester Police Department went to Michael's Cigar Bar, to assist Worcester Fire and EMS who were trying to gain access to the roof by using an outdoor fire escape near the front of the premises as they had received a call that people were on the roof of Michael's Cigar Bar overdosing. Once Fire reached the roof they did not find anyone and asked employees and patrons inside the premises if they knew where the victims were. They stated they had no idea and Officer Ciru asked dispatch to contact the person who reported the call to get a better location of the victims. As Officer Ciru as receiving call back from dispatch a female came through the doors between the Michael's Cigar Bar and Citizen Kitchen and directed Police, Fire and EMS through the courtyard area to the rear entrance across the courtyard from Michael's Cigar Bar and then to the roof top.

Upon ascending to the roof first responders found several people on the roof. Three males unconscious and unresponsive. Two of these males had agonal breathing and the third male had no pulse. Two females and two males were removed and escorted from the roof to the front of Michael's Cigar Bar by first responders. All were actively overdosing and subsequently transported via ambulance to the

hospital. The remaining males needed to be removed off the roof top via buck of the Worcester Fire Department Ladder 3. The victims had to be assisted by several officers from the bucket and into the ambulance. One of the two males who were removed by the bucket truck had no pulse and was not breathing. One individual was subsequently pronounced deceased at the hospital.

Officer Ciru was able to ascertain that 2 of the victims that were overdosing on the roof were employees of Michael's Cigar Bar. Employees interviewed by Officer Ciru stated that they go up to the roof of the premises after closing sometimes to hang out and have drinks.

On June 21, 2022 Detective Joseph Essex and Police Officer Glenn Stout from the Worcester Police Department went to the premises and retrieved video of June 20, 2022 between the hours of 1:00 a.m. and 2:30 a.m., the night the incident occurred.

Also, observed on video was a former employee entering Michael's Cigar Bar and remaining on the premises well after the 2:00 a.m. closing time.

On June 30, 2022 Sergeant Thomas Needham and Officer Stout conducted a walkthrough of Michael's Cigar Bar to get a better understanding of the layout of the property. An employee of the premises, Christen Roy, advised them that they could access the stairwell to the rooftop in the building across the courtyard from Michael's Cigar Bar by going through the basement.

Attorney Robert Hennigan appeared along with Mark Esperti the manager of the record to respond to the violation.

Attorney Hennigan stated that with regard to Rule #29 which is the violation occurring on the premises that there was actually no injured persons on the premises of Michael's Cigar Bar. Sergeant Needham stated not on the premises but the people involved used the premises basement, the hallway and under the courtyard to access to property adjacent to them.

Sergeant Needham testified that an employee of Michael's Cigar Bar was made aware of the people on the adjacent roof and did not alert the first responders about people being on the roof when asked by first responders on how to access the roof of the premises and Worcester Police believed that staff could have taken greater action to provide access to the adjacent property so the first responders could check the location.

Mr. Esperti stated that he investigated himself what happened that evening and he believed that the bartender who told the first responders how to access the premises was unaware about the emergency on the adjacent roof and when another employee asked the bartender how to access the adjacent roof she didn't explain to him why she needed to go up there.

Mr. Esperti testified that the seven (7) people up on the roof all snuck up to the roof of the other premises after they had left Michael's Cigar Bar.

Attorney Hennigan asked if person observed in premises after hours was served any alcohol after hours. Attorney Kalkounis stated that the rule states that no patrons can be on the premises after hours whether has alcohol or not.

Mr. Pimental stated that when the first responders arrived he was not aware of the seriousness of what was happening on the adjacent roof.
