## 21. Westborough Beverage Corp dba Walmart #4387, 25 Tobias Boland Way

Request for package store malt & wine license

Attorney Mark Bornstein along with Pedro Figueroa, the manager the Worcester Walmart, appeared upon behalf of the application.

Mr. Bornstein stated that the Commission members had viewed the premises prior to the meeting and that he would like to review the Ballarin factors for the proposed application.

Mr. Bornstein stated that Worcester's population has increased 14% in the past ten years and the state has allowed additional licenses for the City due to that population increase. Mr. Bornstein stated with that increase and additional package store license would serve the public need. He stated that the location is not within 500 feet of a church, school, or hospital. He stated there are two package stores within two miles of this proposed license, but those two stores are full package stores that primarily serve the Quinsigamond Village neighborhood while this particular location serves the WRTA bus population, and it is also a destination store. It draws throughout the city and surrounding communities. There is a new residential development proposed in the area. There is plenty of parking, the store is large so there is ample space for the storage of the beer and wine and plans propose to install a locked storage area. There is no noise. There is a police detail as well as security of the store. One of the racks would be enclosed to ensure that people who purchase beer and wine would be through a designated cashier. There is a compliance team who review security procedures. The proposed manager of record has over 20 years of retail experience, so he knows the community.

Mr. Bornstein stated that he knows some package stores will speak in opposition to the proposal, but the issuance of these package store licenses is to serve the public need, not "we don't think Walmart should have a package store license".

Pedro Figueroa stated that he has been manager of the store for two years and stated that this store in past two years has changed. It is clean, organized and has more security than any other retailer in the area. He stated that the store wants to ease the distance of customers' shopping trips and offer them less expensive options at this time of high inflation.

**Public Comment** 

Robert Largess, owner of Harrahy's Package Store, spoke in opposition the application. He stated that the vast majority of what he sells is beer and wine and the need for alcohol is already being served in the area near Walmart.

Chair Vigliotti asked Mr. Largess if he had a way to identify which customers come to his store versus going to Walmart. Mr. Largess stated that he is a small store and would not have the capacity to hire someone to do that type of study.

Jim Vasiladis stated that he owns two package stores in the City and theft is big issue with alcohol as it has value in the street and it mostly young adults shoplifting, and Walmart has a large population of young adults going to its store. Also, Walmart has extended hours so there is a risk as who would keep tabs on alcohol during hours when can't they can't sell.

Mr. Vasiladis also stated there is concern how this would effect small business. He stated that the existing stores already serve the public need.

William Kirsty, owner of Olympic Wine and Liquors, stated that 11 years ago this Walmart location was denied a beer and wine license and he knows there has been a population growth in the City but the existing stores already serve the need to the residents.

Bill Talcott, package store owner, stated that there is already enough stores in the vicinity to serve the public need.

Attorney Bornstein stated that with regard to the theft comment that he spoke with the Walmart Corporate office and this store does not have a high theft level due to their security measures and stated that being large corporation is not a Ballarin factor for consideration of issuance of the package store license.

Commissioner Fisher stated that she is torn on this one as being a small business owner herself she knows impact larger stores have on a smaller business so she would be a no vote.

Commissioner Cruz had no comments on application.

Commissioner Vigliotti stated that he had viewed the area and based on the existing stores in the area he feels area is already adequately served.

Upon a roll call vote the Commission voted 3-0 to deny the package store malt & wine license.

Christopher Bettencourt appeared to answer to the violation and waived his right to counsel.

Sgt Needham read the following into the record.

On February 25, 2023, Sergeant Thomas Needham was assigned to the Alcohol Enforcement Unit and went to the Raven Pub after receiving an email complaint that the premises was operating past closing time.

Sergeant Needham observed a number of vehicles parked across from the driveway of the business and a large, illuminated advertisement light glowing in the front window of the premises.

At 2:15 a.m. Sergeant Needham approached the door of the premises and could hear voices inside. He knocked on the door and informed the person inside that it was the Worcester Police. An individual unlocked the door and allowed Sergeant Needham entry.

Sergeant Needham spoke with Christopher Bettencourt, the owner and manager of The Raven, who stated that it was family and friends on the premises.

Sergeant Needham observed five (5) individuals seated and standing at the bar and Sergeant Needham observed two (2) Bud bottles, one (1) Michelob Ultra, one (1) Bud Light and one (1) draft beer on the bar.

Sergeant Needham asked Mr. Bettencourt if anyone was an employee and Mr. Bettencourt responded no.

Sergeant Needham advised Mr. Bettencourt that he needed to clear the bar of the alcohol and to advise the patrons to leave. The patrons attempted to finish their drinks and Sergeant Needham announced that they needed to put the drinks down and leave the establishment which they did.

Mr. Bettencourt was advised that a notice of hearing for the violation would be sent.

Mr. Bettencourt stated that when Sgt. Needham first knocked at the door he stated establishment was closed but then Sgt. Needham stated it was police and he opened the door. Mr. Bettencourt stated that it was relatives on the premises and there was one non-staff member who was a ride for a family member.

Chair Vigliotti asked if what was read in the accurate description of what happened. Mr. Bettencourt stated yes.

Upon a roll call vote the Commission voted 3-0 that the violation had occurred.

The Commission noted that there were no previous violations at the premises.

Upon a roll call vote the Commission voted 3-0 to issue a warning.

## January 21, 2023 - Incident

On January 21, 2023, Officer Patrick Harrington, assigned to the Alcohol Enforcement Unit of the Worcester Police Department, was conducting compliance checks of liquor establishments.

At 2:13 a.m. Officer Harrington entered the Flying Rhino and observed three (3) patrons standing in the dining area who informed Officer Harrington that they were waiting for an Uber. Officer Harrington also observed at the rear bar location five (5) people either standing or sitting at the bar and in front of the patrons were a 12 oz White Claw seltzer, a glass of wine and glasses of beer. Also, located in the area were three (3) people seated at the high-top dining table. Officer Harrington asked if any of the people he observed were employees. They stated no and proceeded to leave the licensed premises.

Officer Harrington asked the bartender why patrons were still on the licensed premises after hours and bartender stated that he thought if they were not drinking they could stay.

Officer Harrington asked the three (3) bartenders on duty to produce their TIPS certification. Only two (2) of the bartenders were able to produce the documentation. The third bartender, identified as Emma Brennan, stated that hers was expired. Officer Harrington advised Ms. Brennan that she could not serve alcohol until she completes the course.

The owner of the Flying Rhino, Paul Barber, was contacted and advised of the violation.

## January 27, 2023 - Incident

On January 27, 2023, Officer Patrick Harrington, assigned to the Alcohol Enforcement Unit of the Worcester Police Department, conducted a follow up investigation from a violation that occurred at the licensed premises on January 21, 2023.

On January 21, 2023, Officer Harrington had informed Emma Brennan, a bartender at the Flying Rhino, that she could not serve alcohol until she had completed her TIPS certification course.

On January 27, 2023 at 8:30 p.m. Officer Harrington went to the Flying Rhino and observed Ms. Brennan in the process of serving mixed drinks to patrons. Officer Harrington asked Ms. Brennan if she had completed her TIPS course and she stated that she did not and was making an appointment to complete the course. Officer Harrington advised Ms. Brennan to cease all service pertaining to alcohol.

Officer Harrington spoke with Paul Barber and asked why Ms. Brennan was still serving alcohol when he was told it was a violation on January 21, 2023. Mr. Barber stated that he was short staffed and did not think it was a major issue because she had an expired TIPS certification. Mr. Barber was advised that this was a violation and would receive a violation notice.

Mr. Barber stated that only thing that he disagreed with was that he didn't think it was a major incident as it was and his reaction was due to the predicament he was put in due to a lack of staff caused by illness that was going on and the person who was supposed to be behind the bar was throwing up and it was under his instruction he told the other bartender she could jump in but get off as soon as possible.

Chair Vigliotti stated that Mr. Barber is admitting to the violation and there have been three other violations in the past.

Upon a roll call vote the Commission voted 3-0 that the January 21, 2023 violation had occurred.

Upon a roll call vote the Commission voted 3-0 that the January 27, 2023 violation had occurred.

Upon a roll call vote the Commission voted 3-0 to issue a two-day suspension with two days suspended and two days to be served May 3, 2023 and May 10, 2023.
