Violation Hearings

6. Blake Enterprises LTD dba Bennie's Café, 13 East Mountain Street

Violation of Rule #14 and Rule #28-manager responsible for premises/server training violation

Jay Melick appeared to answer to the violation and waived his right to counsel.

Sergeant Needham presented the following.

On October 30, 2023, Officer Patrick Harrington was assigned to the Alcohol Enforcement Unit and was conducting a follow-up investigation from a violation that occurred at Bennie's Café. On October 28, 2023, the bartenders serving the public did not have server training certificates and could not produce any documentation that any people on premises had certification.

Jay Melick was contacted via cell phone and was advised of the situation. The owner was able to contact a bartender to cover for the remaining of the night.

Mr. Melick was advised and acknowledged that all employees in the service of liquor cannot serve alcohol until the server training certificates had been completed and have on file and Mr. Melick as given a verbal warning.

On October 30, 2023, at 7:15 p.m. Officer Harrington went to Bennie's Cafe and explained his reason for being there and asked the bartender if he was aware of the previous incident. The bartender stated that he was and was asked to produce a server training certificate and he stated he did not have one. Officer Harrigton asked the other bartender on duty had a server training certificate and she told Officer Harrington she did not.

Mr. Melick stated that he did not dispute was presented and since that time they have had a class, and every person at Bennie's Café has the certificate.

Mr. Melick stated that the employees took the class immediately after incident, but it took three months for the certificates to arrive from the company.

Upon a roll call vote the Commission voted 3-0 that the violation occurred.

Upon a roll call vote the Commission voted 3-0 to issue a Warning.
