TPAG Meeting Minutes April 21, 2021

Meeting minutes for the Feb 2021 meeting were accepted as prepared.

Paratransit Report was presented. Trip requests remain lower than typically expected but continues to increase each month. WRTA received a taxi grant which has allowed for continued one-to-one trips. It is expected that shared trips will begin as more people are vaccinated and more destinations are open and State restrictions are updated.

Customer Service Report for Feb was shared. There were 53 complaints filed. Of the 53 complaints, 44 of them were for fixed route and 8 were for paratransit and 1 was not in either category. Of the 8 paratransit complaints, 6 for vehicles arriving early or late, 1 for a missed trip and 1 was classified as 'Other'. Staff reports that they respond to all complaints that include contact information.

On Demand Transportation update is that although there are still not any accessible taxis on the road in Worcester, Worcester Yellow Cab reports that they have purchased two accessible vehicles which they will be putting into service and will be integrated into their taxi fleet. They vehicles are being prepared for service and drivers will be properly trained.

Riders Action Council This group has not met. Their website is up and running.

Access Advisory Committee (formerly the Disability Commission) for the City of Worcester did not discuss and transit related items.

Transportation Advocacy Coalition met and discussed the resuming of fare collection beginning July 1.

WRTA Advisory Board meeting will be on April 29. It is expected they will discuss resuming fares, social distancing on transit, vehicle cleaning and personnel contracts.

Next meeting is June 16, 2021,1:00pm-2:30pm. This will be a virtual meeting.

Future meetings are scheduled for Sept 15 and Nov 17. There will not be TPAG meetings in July and Aug.
