- I. Call meeting to order Permission to Record! Present
 - A. Jen Safford, Judi Kirk, Raquel Castro-Corazzini, Casey Burns, Nana Owusu-Boahene (Youth Council), Bryant Cortes, Jeury Abreu, Laurie Ross
- II. July minutes and notes Motion to Approve (Judi Kirk), Seconded by Casey Burns.
- III. Update on previous action items -
 - A. DYO will send out the Equity tool and be prepared to present it at the next meeting. Equity tool was sent to the group to go a week prior.
 - B. Speak to the CM about the changes we would like to see for the CMCOY charter. Adding and changing positions.
 - C. Jen Safford will Invite Frankie to come for the September meeting instead of the August. He would share what the CAB is working on and what they are deciding to fund. Jen Safford was not able to send a reminder for him to come and present on the CAB.
 - D. Revisiting the vice chair position and figuring out what we would like to do and who we would like to appoint. Has been hard to find someone for this position as most folks are busy. Committee members like the idea of the vice chair being a Youth Counselor. Judi Kirk presents the idea of having youth from other leadership groups within the city. Raquel stated that in one of the Youth Onboarding training, she learned about having a buddy system until they felt more comfortable. Question is, how can we provide the support for the youth to be part of the Committee on Youth? The Committee agrees that a youth should be the vice chair. When speaking to the Youth Council representative, Nana, Raquel asked what her experience in the committee was like? Nana states that she sometimes is a bit lost on what she is supposed to do, vs youth council, where she has things to work on and do.

IV. Updates -

- A. Raquel After meeting with the city manager, one of the things discussed was about an agenda for youth. The CMs office hopes that this is something the Youth Council would work on. The Committee would have an important role to implement a Community Health Improvement Plan for Youth (CHIPY). We would work with HGW through Casey Burns to start working on an assessment and help create the report which would help create the Agenda for Youth. This could possibly connect to the Shannon and SSYI grants work being done. Group will need to create an ADHOC to work on creating the timeline.
- **B.** Utilizing the Equity Tool We would need to update the charter around DYO and Youth Services. We would also need to choose pieces of the equity tool that we would like to write into the charter. This would help us identify who and what we are missing in the committee.
