- The <u>BioInitiative Report</u> contains peer-reviewed studies that indicate evidence for damage to sperm and reproduction, children are more vulnerable, fetal and neonatal effects, effects on Autism (Autism Spectrum Conditions), Alzheimer's, electrohypersensitivity, blood-brain barrier opening, brain tumors, genotoxicity, neurotoxicity, childhood Leukemia, adult cancers, melatonin, and more. In mainstream media we generally hear only about cancer risks, which can take decades to develop during which time the industry makes great profits. The other shorter-term effects are seldom reported on and so the public is unaware.

A legal opinion from City Solicitor David Moore summarized the legal authority within the City of Worcester for the approval of school department bills prior to payment. In summary, he stated that the November 1995 letter from the Commissioner of Education does not apply to Worcester since the School Department is one of the City's departments which falls under the rules and regulations of the City Charter.

Therefore, the Administration recommended no changes in the current process of payment of bills of the school department.
