# ESSER Spending Overview



## **ESSER I**

Elementary and Secondary School Emergency Relief I (ESSER I) Fund, authorized under section 18003 of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) signed into law on March 27, 2020.

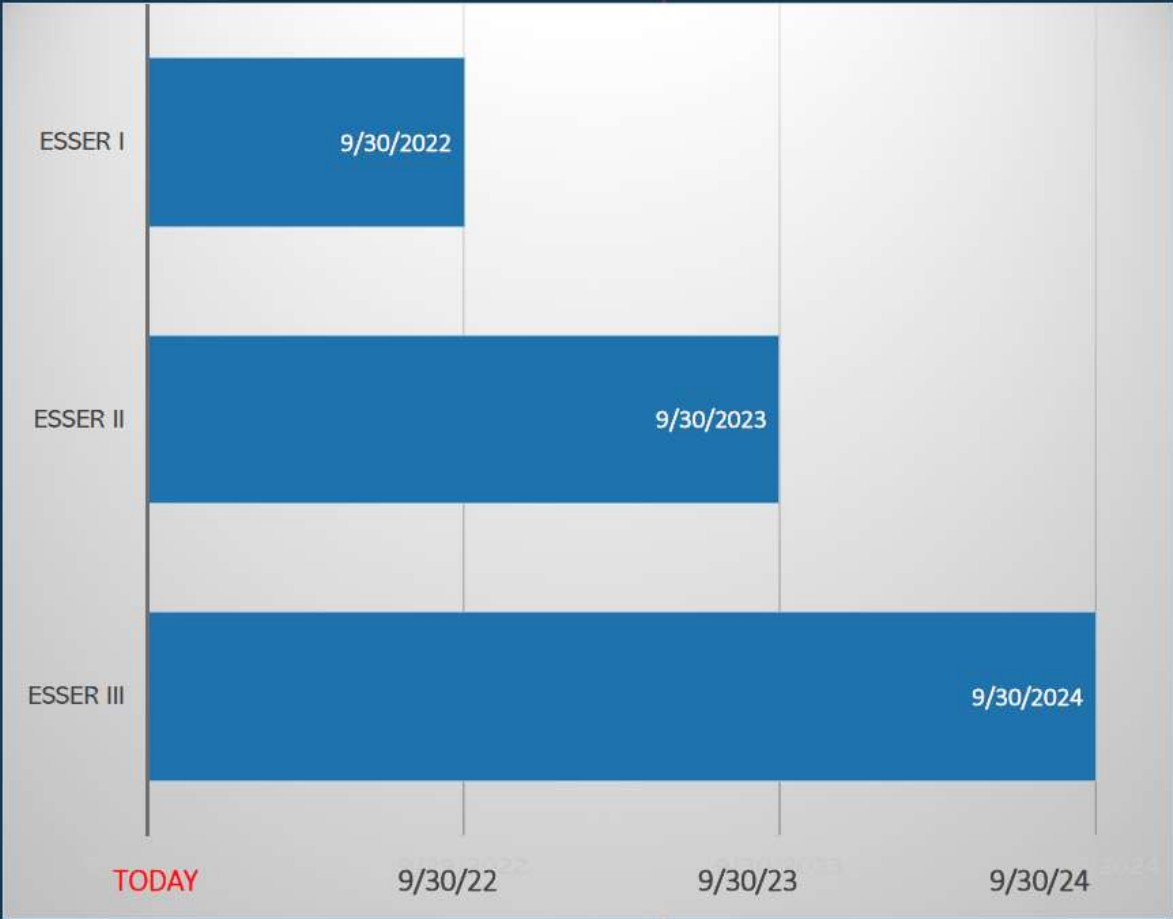
## **ESSER II**

The Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSA), was signed into law on December 27, 2020, and provides an additional \$54.3 billion for the Elementary and Secondary School Emergency Relief Fund.

## **ESSER III**

American Rescue Plan (ARP) Act was signed into law on March 11, 2021, included \$122 billion for the ARP Elementary and Secondary School Emergency Relief (ARP ESSER) Fund

# Funding Requirements

---



- 20% must be used to combat loss of instructional time/learning loss by using evidence-based practices.
- Guidance on the remaining is very broad and closes with “Other activities that are necessary to maintain the operation of and continuity of services...and continuing to employ existing staff.”

# Implementation Plan

AS PART OF GRANT APPLICATION

In the implementation plan (grant application), districts will describe how they will use ESSER III funds to:



Combat loss of instructional time/learning loss by using evidence-based practices (must reserve at least 20% of funds for this)



Use evidence-based practices to address the academic, social, emotional, and mental health needs of students



Address the disproportionate impact of COVID-19 on underrepresented student subgroups



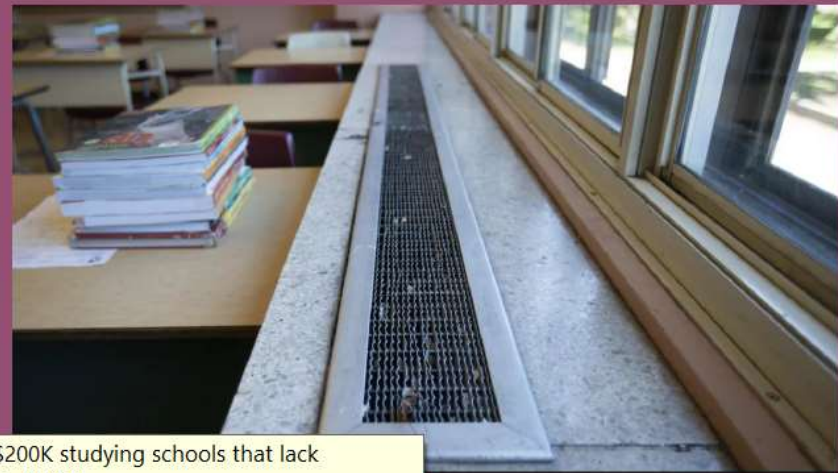

# Use of ESSER Funds for Construction Projects

Building projects must be related to disease mitigation

- Ventilation systems (new install, upgrades, recommissioning, etc.)
- Air purifiers
- Windows and doors
- Bathroom renovations (ventilation, no-touch fixtures, etc.)
- Replacing water fountains with bottle filling stations

*All construction projects must be preapproved by DESE using the Capital Expenditures form (to be submitted with grant application)*

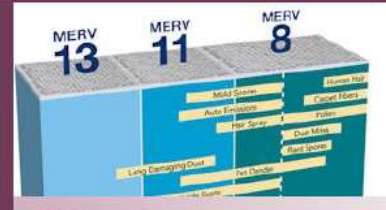
