RE: Relocating Worcester State University Ward 9 – Precincts 1,2,3 to the May Street Building

The purpose of this memo is to provide you a report on the relocation of the Worcester State University polling location from the Wellness Center back to the May Street Building.

The university has contacted the City Clerk's office notifying me that they are not able to accommodate us in the Wellness Center for the 2021 Municipal Election Season. As an alternative to the Wellness Center the university has agreed to host us in the May St. building.

The May St. building is in close proximity to the existing polling location. It meets the requirement for ADA access, parking, and necessary space to set up the voting booths, and other election equipment. This change will not have a disparate adverse impact on voters in Ward 9 – Precincts 1,2,3 access to the polls on the basis of race, national origin, disability, income or age.
