There being a quorum the Chair called the meeting to order at 6:05 PM.

The Commission members and members of the public in the audience introduced themselves. The Chair reviewed the agenda and introduced the guest from Worcester Anti Foreclosure Team (WAFT).

**Guests:**

Ms. Ross and Ms. Assefa introduced WAFT (Worcester Anti Foreclosure Team) as a grassroots organization that strives to stop evictions and foreclosures to help individuals and families that are struggling. WAFT provides assistance and support to homeowners at various stages of the foreclosure process. WAFT helps by educating people of their rights and options, participating in protests against auctions, and directing them to resources that may help. They also gave an overview of the foreclosure situation in Worcester and further explained the steps of the foreclosure process. Ms. Collins and Ms. Fagan were present for the meeting and told their story of and how they became associated with WAFT.

**Public Comment:**

Questions and comments from the public centered on what the City's laws were and if the City was enforcing them. A vacant and foreclosed property ordinance was adopted by the City a few years ago but is still in the process of being fully implemented. Theft is a common problem in vacant properties. Ms. Ross explained that Springfield has a similar ordinance but also hires mediators to work with the banks and the property owners. Mr. Cremer noted that the HRC has subpoena powers within its authority. Ms. McCabe will further investigate and work with the City Solicitor to learn more about this.

**Commission Member Comments:**

The Chair suggested that the Commission consider holding public hearings in each of the City's five districts regarding the foreclosure situation. The Commission will further discuss and consider this at the next meeting in March.

Given the time the Commission moved the discussion on the Worcester Housing Authority Update, Drop the I-Word and Youth and Human Rights to the next meeting.

**Summary of HRC Goals and Accomplishments**

The Chair reviewed with the Commission a 1999 report that outlined goals for the HRC. Many of the goals have been accomplished but there are still goals that are pending and new ones that can be added such as expanding and improving the HRC webpage and outreach to youth.

**Public Comment:**

Ms. Norton and Mr. Cremer noted that City's youth are underrepresented and are often bullied particularly for having disabilities that are not always visible or obvious.
