# 13. Resuli LLC, 171 Stafford Street

# • Request for restaurant all alcohol license

Ira Resuli, participating remotely, stated that she is looking to obtain the liquor license. She stated that she submitted photos of where liquor would be stored that the Commission had requested at a previous meeting. She stated that they would be open from 6:00 a.m. to 3:00 p.m. and that she looking to mainly serve mimosas.

Commissioner Fisher asked why Ms. Resuli would looking for a full liquor license when she only planned to serve mimosas.

Chair Vigliotti stated that they viewed the premises at a previous meeting, and they had great concern about the storage area and seating and the fact it was a breakfast and lunch only establishment and asked if she still wanted to obtain a full liquor license. Ms. Resuli stated that she still looking for full liquor license.

Commissioner Fisher stated that she had concerns as request seems a little robust for a breakfast place.

Commissioner Cruz asked why Ms. Resuli needed a full liquor license if only wanted to serve mimosas. Ms. Resuli stated that in case she does offer different types of drinks in future she like to have the full license but in beginning it just mimosas.

Ms. Resuli stated no that will not be full bar and the focus will always be the food and the drinks are something that customers have requested.

Chair Vigliotti asked how she planned to check ID. Ms. Resuli stated that she asked for IDs from customers and that she is willing to do everything that needs to be done to create a safe environment.

Commissioner Fisher stated that she still has concern that it is full alcohol request for business like this and she is not confident that applicant has looked into properly what is required to serve alcohol.

Commissioner Cruz stated that she agreed with Commissioner Fisher, and this is just a breakfast and lunch establishment.

Chair Vigliotti stated that Commission has concern with the location and the seating and whether there is a need for a full liquor license at this location but does not feel the Commission would have problem with a beer and wine license request.

Upon a motion and seconded the Commission voted 3-0 to deny the request for a restaurant all alcohol license as they did not feel this was a proper location or facility for a full liquor license.

# 15. Paku Corporation, 215 Chandler Street Request to credit 2023 liquor license to year 2024 liquor license

Jose Rivera, participating remotely, stated that in 2023 they paid for liquor license but didn't have chance to use it because of change of management and then in summer of 2023 the fire department said they needed a sprinkler system for entire building and they decided to open for a month without liquor but sales were very poor so they decided to close and they are working with owner of building to have sprinkler system installed. Mr. Rivera stated that the sprinkler system should be installed in April, and they are just requesting that the payment for the 2023 liquor license fee paid be applied to 2024.

Commissioner Fisher stated that the Commission needs to be careful about setting about precedent about doing this.

Chair Vigliotti stated that he would concur with Commissioner Fisher so he would motion that the request be denied.

Upon a roll call vote the Commission voted 3-0 to deny the request.

# **Violation Hearings**

# 16. Dream 6 Estate LLC dba Dream Market, 369 Burncoat Street

# • Violation of Rules #6, #21-Sale to minor, manager violation

Samuel Boiquaye along with his attorney Al DeNapoli appeared upon behalf the violation.

Sergeant Needham presented the following.

On November 18, 2023, Officer Patrick Harrington and members of the Alcohol Enforcement Unit conducted compliance checks on various package stores throughout the city. A 17-year-old male accompanied the officers during the evening. The underage male was instructed to enter a package store and attempt to purchase a six pack of Corona bottles without providing identification. The male was

instructed if asked for identification to politely inform the clerk he did not have one. The male was instructed not be confrontational at any time if not sold the item and to leave the store. The male was given the same instructions every time he entered a different store. Prior to departing and upon return to the police station the male was administered an alcohol breathalyzer test.

As the underage male entered the stores Officer Harrington had an unobstructed view of the entrance and the times were noted upon entry. During the checks the male attempted to purchase alcohol from 20 stores.

At 11:06 a.m. the 17-year-old male entered Dream Market. The male approached the female clerk at which time she asked for his identification, and he informed her he did not have any. A patron behind him offered the clerk her I.D. and the store allowed the underage male to pay and carry of the Corona which is an alcoholic beverage.

Mr. DeNapoli stated that Mr. Boiquaye's mother was behind the counter at the time of the incident.

Mr. DeNapoli stated the report is correct as Mr. Boiquaye's mother believed that the person who presented the ID was with the individual who came in and didn't know they weren't together. Mr. DeNapoli stated that the store is very responsible, and they have a scanner that the store uses at all the time and Mr. Boiquaye as well as his mother are server trained.

Mr. DeNapoli stated that based on the circumstances if the Commission finds a violation that only a warning be imposed.

Chair Vigliotti stated that his concerns that person who did purchase the liquor bought it for someone who was underage, and he recommended a two-day suspension with one day served.

Upon a roll call vote the Commission voted 3-0 that the violation did occur.

Upon a call vote the Commission voted 3-0 to impose a two-day suspension with one day to be served on February 24, 2024.

# 17. Worcester Randall Package Store, Inc., 108 Canterbury Street

#### • Violation of Rules #6, #21-Sale to minor, manager violation

Rajnikant Manuhbai Patel along with a translator appeared to answer to the violation and waived right to legal counsel.

Sergeant Needham presented the following.

On November 18, 2023, Officer Patrick Harrington and members of the Alcohol Enforcement Unit conducted compliance checks on various package stores throughout the city. A 17-year-old male accompanied the officers during the evening. The underage male was instructed to enter a package store

and attempt to purchase a six pack of Bud Light cans without providing identification. The male was instructed if asked for identification to politely inform the clerk he did not have one. The male was instructed not be confrontational at any time if not sold the item and to leave the store. The male was given the same instructions every time he entered a different store. Prior to departing and upon return to the police station the male was administered an alcohol breathalyzer test.

As the underage male entered the stores Officer Harrington had an unobstructed view of the entrance and the times were noted upon entry. During the checks the male attempted to purchase alcohol from 20 stores.

At 1:30 p.m. the 17-year-old male entered Worcester Randall Package Store Inc. and was able to purchase a six pack of Bud Lights cans which is an alcoholic beverage without providing any identification.

Members of the Alcohol Unit notified the store of the violation. While on scene it was determined that the staff serving the public did not have the proper serving training certificates.

Through the translator Mr. Patel stated that he was training a part time worker, and he was one who sold the alcohol without asking for ID and that employee was fired. He stated that when the officer asked for the server training certificates, they were expired but they now have current ones and sent them to the officer. He stated they have a scanner now and presented to Commission several fake IDs that the store has confiscated since installing the scanner.

Mr. Patel stated that the report was right, and they fired the employee, and they made a mistake and they trying to improve, and they are not serving anyone who doesn't have an ID.

Chair Vigliotti stated that the premises has had previous violations before City of Worcester. Mr. Patel stated that they also have a five-day suspension that they have to serve from the Alcoholic Beverages Control Commission, so they are just asking for a warning from the local board on this violation.

Chair Vigliotti stated that the violations seemed to be occurring a lot at this premises and violations are occurring too frequently.

Officer Harrington stated that going through police files that a few years ago the police assisted this establishment on the TIPS process certification as they had this violation before.

Upon a roll call vote the Commission voted 3-0 that the violation did occur.

Upon a roll call vote the Commission voted 3-0 to impose a four-day suspension with two days served March 2, 3, 2024.
