The Planning Board met for its regular meeting on Wednesday, April 5, 1972 in Room 209, City Hall.

Members present were: Frederic R. Butler, Carlton B. Payson and Lloyd Anderson.

Also present was Roger W. Bruce, the newly appointed Board member.

Others present were: Francis Donahue, Gerard F. McNeil, Alexander Pridotkas and John Reney.

<u>Call to order</u>. Chairman Payson called the meeting to order at 4:40 P. M. He also introduced and welcomed Roger W. Bruce as the new member of the Planning Board.

Crystal Park - Neighborhood Development Program. Mr. Charles Zettek of the Worcester Redevelopment Authority presented a preliminary proposal of an urban renewal plan for the Model Cities area and a Development Plan for the Main South M.N.A. which is a mini version of the city's Master Plan for the area. It is a rehabilitating, cleaning, painting and fix-up program.

Mr. Anderson asked if there would be any substantial changes in the zoning of the area.

Mr. Zettek replied in some areas they would be changing some business zoning to residential catagories, but the uses would remain as non-conforming uses.

Mr. Butlerasked about the off-street-parking and Mr. Zettek said the zoning regulations in effect would govern the amount of off-street-parking required. (It is now 1 to 1).

Mr. Butler made the following motions: that the Worcester Planning Board hereby finds that the Neighborhood Development Plan, Main South M.N.A. submitted by the Worcester Redevelopment Authority is based upon a local survey and conforms to the

Comprehensive Plan for Worcester as a whole.

Also: that the Worcester Planning Board hereby finds that the Crystal Park Urban Renewal Plan submitted by the Worcester Redevelopment Authority is based upon a local survey and conforms to the Comprehensive Plan for Worcester as a whole.

The water were seconded by Mr. Anderson and they were unanimously voted.

Grovewood - definitive subdivision. Because of Mrs. Bagley's absence, the Grovewood definitive subdivision vote was tabled until the next meeting. The date was set tentatively for April 14 at noon.
