USE BACK OF FORM IF ADDITIONAL SKATES ARE REQUIRED

Agreement with all terms below and a \$25.00 deposit per pair of skates (maximum \$75.00) are required for all skate rentals.

Deposit must be made with a major credit card or cash. Credit card will not be charged unless skates are not returned. It is your sole responsibility to inspect the skates prior to use and ensure proper condition, size and fit for yourself and others in your group. The skates must be returned in good condition, reasonable wear and tear accepted, and you must inform the skate attendant if there were any issues with the skates while you had them in your possession.

READ CAREFULLY (TRANSLATIONS AVAILABLE) -

I HEREBY ASSUME ALL RISKS OF INJURY, DISABILITY, DEATH, LOSS OR DAMAGE TO PERSON OR PROPERTY INHERENT IN, AND/OR IN ANY WAY CONNECTED WITH, ATTENDING, PARTICIPATING IN, RENTING SKATES, AND SPECTATING AT ICE SKATING, OR OTHER ICE ACTIVITIES AT THE FACILITY.

Skates are for use by individuals listed ONLY (non-transferrable). Skates may not be taken off property. Skates must be returned when not in use.

***If the skates are not returned on the same day as rented (or earlier if requested by management) I agree to forfeit my cash deposit or have my credit card charged \$25.00 for each pair of skates not returned. Unreturned skates or rule violations will also result in the denial of any future skate rental requests. If for any reason the credit card is declined, I will immediately provide payment by another means upon being contacted at the address or phone number listed above.**

SKATE RENTALS ARE FOR TWO HOURS ONLY. IF SKATE SIZE IS IN A HIGH DEMAND, MANAGEMENT RESERVES THE RIGHT TO NOTIFY THE RENTOR TO RETURN SKATES AFTER A TWO HOUR PERIOD.
