Enrollees must have Medicare parts A & B, continue to pay their Medicare Part B premium, have permanent residence within our Medicare Advantage service area, and meet CMS enrollment limitations related to ESRD (End Stage Renal Disease). Members are enrolled in Medicare Part D and the Medicare Part D premium is included in the monthly plan premium. Members must use contracted providers and obtain authorized referrals for specialty care services. Member disenrollment must comply with CMS guidelines for timing and notification. FCHP is a health care services company with a Medicare contract.
