Whenever two or more notifications are required by this policy, a periodic review involving the Chief of Police, the involved commander(s), and any other officer as requested by the Chief of Police shall be made for policy and training development.

If an incident occurs, which is of an obviously severe nature when viewed objectively, it shall be analyzed in conjunction with the policy or policies encompassed, and with all evidence at hand. When necessary, a further investigation shall be conducted until an accurate conclusion is attained. This review or analysis shall be conducted at the earliest possible time after the incident is stabilized, any imminent dangers are alleviated, and necessary information is acquired.
