The Chair called the meeting to order at 5:30 p.m.

**Action:** Upon a motion by Commissioner Escobar and seconded by Commissioner Canton, the Commission voted 3-0 to postpone items 3 and 5 as noted to 1/7/19.

### **Public Hearings:**

**10d. Enforcement Order: Country Club Acres** (aka Garrison Avenue & 190 East Mountain Street; Cobblestone Lane (fka Paradise Point)) (CC-2007-025; DEP #349-931; CC-EO-2017-009; UAO-CE-18-6W001)

**Action:** Item 10d was taken out of order first. Commissioners discussed the need for more information on erosion control for each subphase of project and clarified that monitoring reports were needed for snow melt or rain, not snow. They requested that the applicant wait to discuss where demarcation of work under this Order of Conditions versus a new Notice of Intent filing until the full board was present.

## New Business – Requests for Determination of Applicability

4. Work on following properties related to Signal and Intersection Improvements at Holden Street, Drummond Avenue, and Shore Drive: 78 Holden St (MBL 33-004-29+30), 81 Holden St (33-011-65+66), 82 Holden St (33-004-31+32), 87 Holden St (33-011-00133), 89 Holden St (33-011-00130), 90 Holden St (37-022-00002), 97 Holden Street (33-011-00132) and 110 Shore Drive (MBL 37-025-0001A) (CC-2018-099)

Project: Determine whether or not the proposed work outside of the existing rights of way associated with the reconfiguring the roadway layout and conducting related grading, utilities, drainage, paving, and site work is subject to the Commission's jurisdiction.

Jurisdiction: City of Worcester Wetlands Protection Ordinance

**Action:** Item 4 was taken with item 6. Discussion clarified that the church properties "PUE-06 and TE-10" were not part of RDA, as they would instead be covered by the NOI filing. Upon a motion by Commissioner Escobar and seconded by Commissioner Amory, the Commission voted 3-0 to issue a negative determination.

Holden Street (from Parkton Avenue to Longwood Avenue), Drummond Avenue (from Holden Street westerly ~200') and Shore Drive Right of Ways (from Holden Street easterly ~900') and abutting properties - including 84 & 90 Holden Street and 110 Shore Drive (MBL 37-025-0001B; 37-022-00002; & 37-025-0001A): Notice of Intent by the City of Worcester Department of Public Works & Parks (CC-2018-097, DEP #349-1231) Project: To reconfigure the roadway layout and conduct related utility installation, grading, drainage, paving, and site work and to request a waiver of the City of Worcester Wetlands Protection Regulations performance standard 4.2.4. Jurisdiction: The MA Wetlands Protection Act and the City of Worcester Wetlands Protection Ordinance Action: Upon a motion by Commissioner Escobar and seconded by Commissioner Amory, the Commission voted 3-0 to close the public hearing and issue an order of conditions (CE, DC; 3-0). Upon a subsequent motion by Commissioner Escobar and seconded by Commissioner Canton, the Commission voted 3-0 on those conditions.

# 1. 21 Paradox Drive (MBL 25-052-00028): Notice of Intent by Raymond Sansoucy (CC-2018-002, DEP #349-1182)

Project: To conduct, partially retroactive, activities to remove vegetation and construction debris and to re-grade and stabilize portions of the site, along with associated site work.

Jurisdiction: The MA Wetlands Protection Act and the City of Worcester Wetlands Protection Ordinance Public Hearing Opened: 1/10/2018

**Action:** Taken out of order with Item 10c; Commissioners Charpentier, Escobar, Canton, and Amory were present, though Commissioner Canton did note vote per the Mullin rule. Upon a motion by Commissioner Escobar and seconded by Commissioner Amory, the Commission voted 3-0 to lift the enforcement order and manage through an Order of Conditions. Upon another motion by Commissioner Escobar and seconded by Commissioner Amory, the Commission voted 3-0 to issue a series of conditions.

# 7. 210 Southwest Cutoff (MBL 34-034-00011): Notice of Intent by St. James Realty, LLC (CC-2018-098) (DEP#349-XXXX)

Project: Construct two commercial self-storage buildings (~177,000 SF) with associated parking and to conduct related site work.

Jurisdiction: The MA Wetlands Protection Act and the City of Worcester Wetlands Protection Ordinance **Action:** As there were a number of staff an commissioner questions not yet answered by the applicant and the filing did not have an assigned DEP file number yet, the hearing could not be closed. Upon a motion by Commissioner Escobar and seconded by Commissioner Canton, the Commission voted 3-0 to open the hearing, hear from the applicant's representative about the project, and continue the hearing until January 7, 2019.

Project: Replace the existing athletic field improving existing walking track and to conduct related site work. Jurisdiction: The MA Wetlands Protection Act and the City of Worcester Wetlands Protection Ordinance

**Action:** Upon a motion by Commissioner Escobar and seconded by Commissioner Canton, the Commission voted 3-0 to close the public hearing and issue an Order of Conditions. Upon a subsequent motion by Commissioner Escobar and seconded by Commissioner Canton, the Commission voted 3-0 on those conditions.
