## 15. Enforcement Order and Violation Updates

a. 100 Goldthwaite Road (AKA White Birch Commons (FKA Burncoat Gardens)) (CC-2013-057; DEP #349-1075; CC-EO-2017-001)

Staff provided an update that the applicant has provided correspondence that the roadway grades are relatively final and require minimal earthwork and that the applicant's Professional Wetland Scientist has advised that the road be paved as an erosion control measure. The Commission agreed that this was the appropriate step forward.

b. Arboretum Village (CC-EO-2016-002; CC-2009-042; DEP #349-979)

The applicant's representative requested that the Commission allow the development of lots 67-68 Honeysuckle Lane and provided information from a geotechnical engineer that Slope B has been and will continue to be stabilized. Upon a motion by Commission Amory and seconded by Commission Khaled, the Commission voted 3-0 to amend the enforcement order to allow work that has been approved by the Planning Board on lots 67-68 Honeysuckle Lane.
