## New Business - Requests for Determination of Applicability

## 1) 525 Lincoln Street (CC-2024-003)

Anthony Damiano (participating remotely) of GZA GeoEnvironmental, on behalf of the applicant, Massachusetts Electric Company, stated this electrical distribution project takes place to the south of Lincoln Plaza. The applicant is seeking a negative determination for work within 100' of Coal Mine Brook. The work will consist of the installation of 1 utility pole between existing poles on an existing distribution line that travels along Lincoln Street. The work will be done with a bucket truck from the Lincoln Plaza parking lot with minimal ground disturbance and is approximately 60'-70' from an intermittent stream.

Commissioner Magliaro asked if they will excavate with an auger; Mr. Damiano stated that is correct.

Commissioner Magliaro asked what they will do with the excess soil; Mr. Damiano stated they will backfill and take any excess off site.

Commissioner Magliaro asked if the site will be stabilized; Mr. Damiano stated they will if necessary.

No public Comment.

Upon a motion by Commissioner Canton, Seconded by Commissioner Nystrom the Commission voted 6-0 to issue Negative Determination of Applicability.

## **New Business - Notices of Intent**

## 7) 15 Endicott Street (CC-2023-079 & DEP#349-1382)

No representative present for the meeting.

No discussion amongst the Commission.

Upon a motion by Commissioner Magliaro, Seconded by Commissioner Truman the Commission voted 6-0 to postpone the hearing to the 1/29/24 meeting.

## 9) 204 Granite Street, 414R & 504R Massasoit Road, 1065 Millbury Street, and 253 Providence Street (aka the M165 Transmission Line) – Notice of Intent (CC-2024-001 & DEP#349-13XX)

Gregory Russo of TRC Companies, on behalf of the applicant, New England Power Company, described the location of the project and explained the work will include line maintenance, structure replacement, and timber matting in the resource area. They are still awaiting a DEP # but would like to have a discussion with the Commission while they await.

Commissioner Canton asked for information regarding access to the structures to be replaced, specifically 59 & 58 and 57 & 56; Mr. Russo stated 59 & 58 are in upland area with access from either Granite Street along the existing access road or from the high school at the top of hill. 57 & 56 will also be accessed via Granite Street. The existing access there is within the 25' and the 30' buffer but does not require any improvements, they only need to use it for access.

Chair Charpentier asked if this a continuation from soil boring efforts that took place last year; Erin Whoriskey Cahill of National Grid (participating remotely) stated it is but it is a separate project.

Chair Charpentier asked about timelines for completion of work; Ms. Whoriskey Cahill stated the City approvals took longer to obtain than they anticipated but at this point, they are just waiting for appropriate weather.

Mr. Flint added clarity on the timeline and where it stands with the City.

Chair Charpentier noted issues with crews navigating timber mat crossing and wants to understand how it's going to be used and what impacts it has.

Chair Charpentier asked about staging areas on the plans; Mr. Russo stated these are the pole pads; Ms. Whoriskey Cahill the pole pads are placed in certain areas due to the angle of the line and specific safety and code requirements that must be followed.

Chair Charpentier asked about the duration of work; Mr. Russo stated it will take place from February to October.

Mr. Flint asked about the process to restore the BVW areas after the timber matting is removed and how that differs from stabilization in upland areas; Mr. Russo stated when timber mats are removed and stabilization is needed, they will use straw and a seed mix to restore. Mr. Russo added that the mats typically allow vegetation to come back naturally without much intervention.

No public Comment.

Upon a motion by Commissioner Canton, Seconded by Commissioner Magliaro the Commission voted 6-0 to continue the meeting to the 1/29/23 meeting.

#### b. 616 Plantation Street (CC-2022-003 & DEP#349-1313)

Mr. Flint stated this was issued in 2022 for construction of Coal Mine Brook Park. The as-built plan was in line with what was approved. Mr. Flint noted some area by the observation deck that did not appear to be 100% stabilized. He did not note any erosion on the hillside but there was not much vegetation as far as he could tell.

Chair Charpentier stated the area was not vegetated before; Mr. Flint ask if they would like to condition removing the erosion controls along the river and cut the straw out of the waddles on the hillside as an additional erosion control measure prior to issuing the COC; Chair Charpentier stated that would be nice.

Upon a motion by Commissioner Truman, Seconded by Commissioner Magliaro, the Commission voted 6-0 to issue the Certificate of Compliance.
