#### 1. Call to order and introductions

#### A. Review of FY 19 annual report and discussion of goals for FY20

- Director Turchek summarized the purpose of the annual report, as a product developed per City Manager's request for a report from each board or commission on an annual basis Activities:
  - Initiative 1: Address police and community relations through continued follow up and communication with the Worcester Police Department
  - Initiative 2: Conclude Neighborhood Watch Meetings Survey and present findings and recommendations
  - Initiative 3: Host annual public hearing and hate crimes and reporting
  - Initiative 4: Host Eleanor Hawley Human Rights Day Award
  - Initiative 5: Collaborate with Worcester Tree Initiative to understand the environmental justice issues related to loss of tree canopy in different city neighborhood

#### Discussion:

- Can Initiatives 1-3 be combined into one with a subheading under each?
- Commissioners reflected on the success of the Eleanor Hawley Award Ceremony, and discussed
- Tentative decision to hold the next ceremony in December 2020

- Affordable Housing
- Poll watching could be another initiative
- Any work to be done around helping our immigrant communities feel safe
- Focus on immigrants hosting a citizenship day, lawyers helping with applications

- Commissioner Robinson spoke to the Commission about the upcoming Pride parade and festival taking place on September 7th.
  - o Participants are asked to assemble at Institute Park at 10am
- Theme of the Pride Festival is "Stonewall 50"
  - o Commissioner Robinson provided t-shirts for Commissioners.
  - o "Stonewall 50" is going up the back of the T-shirt, because Stonewall is the "backbone" of the LGBT movement
  - Pink triangle was the symbol used in Nazi Germany to identify members of the LGBT community and was later used as a symbol of pride around the Stonewall Riots in 1969.
- Commissioner Robinson spoke with Reverend Judy regarding September meeting at Hadwen Park Congregational Church
- Officer Sharon McQueen will also be joining for September meeting
