Attorney Brodeur stated there is no connection with old owners and that the establishment will be 21 years and older concept only. No underage allowed. Some light food will be available.

The lease for the premises has not been finalized.

Peter Lukes stated he was not willing to act on item until he saw a final lease between landlord and tenant and not a sublease with prior owner. Mr. Lukes also noted that there was \$10,000 being financed with the old owners and was not willing to act on this application if there was any financing through the prior owners.

Mr. Lukes stated he would not act until there was absolutely no connection between the new applicant and the old owners.

Attorney Brodeur stated that there should be no problem with obtaining a final lease and changing the financing.

Mr. Lukes made motion to hold item for two weeks. Karon Shea seconded.

Peter Lukes requested to know the status of the license at 90 Harding St.

William Chase appeared at the meeting and stated that he is still in possession of the license. He has functions at the premises. He presented several contracts for functions that will be held in the next few months. He stated that most of the functions are held in afternoons and that is why if Police go by in evening the establishment is closed. Peter Lukes asked Mr. Chase if there was a dispute regarding the lease at the property. William Chase stated yes there was a lease dispute and the parties involved were in court relative to that matter.

Joshua Head, Frank Zirpolo and Attorney Edwin O'Brien appeared at the meeting also. Joshua Head claims that he has a lease for the property also and that William Chase has locked him out of the property. Mr. Chase stated that the lease was contingent upon Mr. Zirpolo obtaining a liquor license but Mr. Zirpolo withdrew his application when he was informed that the police would not approve him. Joshua Head stated that he has submitted an application and he has a lease at the property and he has paid Mr. Chase for first, last and security but Mr. Chase had him locked out of the premises. Mr. Chase stated this is a private dispute and the parties would be meeting in court that afternoon relative to this matter. Peter Lukes stated problem Commission has is that the License Commission is not sure who is in control or has possession of the property. Attorney Jennifer Beaton stated that this item was advertised for cessation of business and if the Commission wishes to hold a violation hearing the meeting would have to be continued and new notice would need to be sent out. Peter Lukes requested that letter be sent out for a violation hearing as the License Commission is not aware of who is currently in possession of the liquor license. Joshua Head asked if William Chase could continue operation of the business. Peter Lukes stated that since there was no vote taken on the cessation of business and that the violation hearing notice needed to be sent to the license holder for another hearing that the business may remain open
