## Call to Order -

Chair Shea called the meeting to order at 10:00 am.

## Approval of the Minutes -

The Commission did not approve the minutes for $3 / 28 / 13$. The minutes were not ready.

## Unfinished Business

## 1. 315 Grove Street - Jillian's Billiards

## Petition: Request for alteration of premises to allow outside seating

Tobias Cassidy, General Manager of Jillian’s, stated that the purpose of the application was to obtain permission for outdoor seating for 20.

Chair Shea asked if the applicant had provided detailed dimensions of the area where they want to have the outdoor seating. Mr. Cassidy stated that presently they have a bench against their building to the right of the entrance that the patrons use as a smoking area. They want to add 4 tables in that area to allow up to 20 people to eat or drink outdoors during the nice weather. Mr. Cassidy also stated that they plan to move a handicapped space to allow for the seating if they are approved. They also plan to fence off the area and ensure that no one can get in without coming through the restaurant first. Mr. Cassidy also assured that there will be no bar or any entertainment outside.

Lt. Johnson stated that the fence needs to be high enough so that people can't jump over it. Mr. Cassidy was amenable to that.

Christine Moore, Goodwill representative, stated she was concerned with the size of the parking lot since it's a shared parking, more specifically about the availability of parking for her customers and the cleanliness of the lot. Ms. Moore stated that she had an opportunity to speak to the applicants and that the situation seems to have improved. She stated she is not against the petition; she just wants to ensure that this is done in a way that there is no negative impact to Goodwill.

Mr. Cassidy assured the Commission that he plans to keep it clean and suggested that signs be posted designating Goodwill's parking and that violators will be towed at owner's expense.

Commissioner Mullan stated that parking is not under the purview of the Commission so the agreement has to happen between the individual parties. He stated that at the site visit this morning he saw other businesses using Jillian's parking.

Commissioner Salvidio stated that signage should solve most of the issues.
Mr. Fontane stated that before any cars are towed the signage would have to be in place. He also stated that if they are eliminating any required parking then they are only allowed 12 outdoor seats. The Commission can approve it and defer to the Zoning Ordinance for the number of seating allowed.

The manager of Commerce Bank stated that there has been a verbal agreement between Commerce Bank and Jillian's that Jillian's patrons can use Commerce bank parking after 7 p.m. and Commerce bank employees can use Jillian's parking earlier in the day. He stated that it hadn't been working out well but they reached an agreement the week before and it seems to be working.

Mr. Fontane suggested that the applicant rearrange the outdoor seating and move it closer to the street, that way they wouldn't be required to eliminate parking and can have 20 outdoor seats.
Ms. Steele asked what the hours for the outdoor seating will be. Mr. Cassidy stated that it would be $4 \mathrm{pm}-1$ am Mondays and Tuesdays, 4 pm to 2 am Wednesdays and Thursdays, 2 pm to 2 am Fridays, 12 pm to 2 am Saturdays, and 12 pm to 1 am on Sundays.

Upon a motion by Commissioner Salvidio, the Commission voted to approve the outdoor dining for 20 seats as amended by the diagram.

## 2. 241 Southbridge Street - AA Brothers dba Emperor's Club

## Violation of Rule \#14 (conditions on liquor \& entertainment license)

Chair Shea swore everyone in. Attorney Louis Cassis, Sergey Yugay, and Levon Terzian were present for this matter.
Lt. Johnson stated that this is a continuation of a violation hearing for violations of the conditions of approval regarding the Sky Box, the video surveillance, and the privacy areas.

Two weeks ago, the police inspected the location and $98 \%$ of everything discussed was complied with. The only remaining issue is with the couches and chairs in the Sky Box that needs to be removed.

Attorney Cassis stated that part of the problem was that they were required to keep 10 days' worth of surveillance and they were having issues keeping all that video. He also stated that the violations were lack of understanding rather than blatant or deliberate violation.

Mr. Yugay stated they just need a little more time to remove the couches from the Sky Box because they were built for the space. They are large and they need to be broken down in order to be removed.

Upon a motion by Commissioner Mullan, the Commission voted to find the applicant in violation of condition \#6 in the license. Chair Shea voted yes, Commissioner Mullan voted yes, and Commissioner Salvidio voted yes.

Upon a motion by Commissioner Mullan, the Commission voted to give the applicant a warning. Chair Shea voted yes, Commissioner Mullan voted yes, and Commissioner Salvidio voted yes.
Chair Shea took up item \#15, a petition for a change of manager to Sergey Yugay.
Lt. Johnson stated that Mr. Yugay passed the background check.
Chair Shea stated that she was concerned for the instability and the numerous changes in managers this business has had in the past.

Upon a motion by Commissioner Salvidio, the Commission voted to approve the change of manager application.
