**Call to Order** –

Commissioner Mullan called the meeting to order at 10:00 A.M.

**Old Business**

1. Petition: Request for change of location in same shopping plaza to unit 14A with address of 867 Grafton Street

Petitioner: DVN , Inc. dba Plaza Liquors

This item was re-advertised as applicant did not notify abutters for the first meeting.

Upon a motion by Commissioner Salvidio, the Commission voted 2-0 to approve the change of location for DVN, Inc. dba Plaza Liquors.

### **One Day Liquor Requests**

2. Petition: Request for one day liquor licenses on August 17, 2013 & September 7, 2013

Petitioner: Regatta Point Community Sailing, Inc., 10 Lake Avenue North

Lucas Markgren appeared on behalf of the applications. He stated this is for two events at Regatta Point and the events will be for adult members and sponsors of Regatta Point Community Sailing.

1. Secure area around carnival.
2. Employee list be submitted to the police for background checks.
3. Close at 10:00 pm every night.
4. Paid admission gate with one way in and out.
5. Wands and security check at front gate.
6. Detail of 4 officers every evening: one at the entrance, one at the rear, and 2 roving. Two evening officers arriving from 6 pm – 10 pm and two evening officers arriving from 6:30 pm to 10:30 pm.
7. Saturday and Sunday detail of 2 officers from 12 pm – 6 pm.

16. Petition: Request for entertainment license for tv, dancing by patrons, Recorded music, live music, amplification system, theatrical exhibition and karaoke

Petitioner: Club Milon, LLC, 41 Pleasant Street
