Violation Hearings

22. Faucher & Masson, Inc., dba Main South Discount Liquors, 817 Main Street

Violation of Rules #6, #21 – Sale to underage person

Charles Faucher, Michael Kenkarski and Attorney Paul Sushcyk appeared on behalf of the item.

On May 25, 2013, Officers Mark Jolin and Bill Stout, along with Lieutenant James Johnson conducted compliance checks at various package stores throughout the city of Worcester. An underage male (identifying information held at the Worcester Police Station Alcohol Unit) accompanied the officers and was instructed to enter a package store and attempt to purchase alcohol without providing identification. He was instructed to politely state he did not have identification if asked, not to be confrontational at any time and to walk out of the package store with or without making a purchase. He was given these instructions each time he entered a different store and he was observed both entering and exiting the stores. Prior to going out, the underage male was given a breathalyzer test in the cell room and again upon his return. He was not allowed to carry identification on his person.

At around 4:11 p.m., the underage male entered Main South Liquors, located at 817 Main Street, and purchased a 40 ounce Miller High Life Beer for \$2.45. The underage male informed police that the clerk asked for identification and when he replied he did not have identification the clerk looked at him and said, "yeah, you are over 21." At the conclusion of the sting, Officer Jolin contacted

the business to inform them of the violation and advised that the manager would have to appear before the License Commission.

Mr. Faucher admitted that the violation had occurred.

Commissioner Mullan note that case file showed establishment had been in business for over 50 years with very few violations.

Upon a roll call the Commission voted 2-0 to that violation had occurred.

Upon a roll call the Commission voted 2-0 to issue a warning.
