#### **Hearings**

12. Martwi, Inc., 187 Washington Street – Reinstatement of license

Ms. Steele stated that the ABCC approved the change of manager and Lt. Johnson has met with the license holder.

Upon a motion the Commission voted 2-0 to reinstate the license.

**13.** Meze, 156 Shrewsbury Street- Rule #14 - Operating Sidewalk Dining violations, Alcohol allowed to leave licensed premises

Sotirios Georgiadis appeared to answer to the complaint and waived his right to counsel.

Lt. Johnson presented the following report:

On June 7, 2014 at 12:30 a.m. Officer Edward Saucier drove past Meze, located at 156 Shrewsbury Street, and observed a large group of people standing and sitting outside on the sidewalk patio area. Several people were observed drinking from beer bottles. Officer Saucier was unable to stop at the time but returned at 1:15 a.m.

At 1:15 a.m. Officer Saucier observed a large crowd of people drinking what appeared to be mixed drinks. Several staff personnel were outside as well.

Officer Saucier asked to speak to the manager and a male who stated he was the owner's son came out to speak with Officer Saucier. Officer Saucier explained that the sidewalk patio needed to be closed and he stated that he thought he had until midnight. Officer Saucier pointed out that it was well past midnight and all outside service was to cease at 11:30 p.m.

As Officer Saucier was speaking with the owner's son a female exited the business with a bottle of beer. She walked in front of staff and Officer Saucier and began drinking the beer. Officer Saucier pointed this out to the owner's son, who just shrugged. Officer Saucier informed him to have staff escort the female back inside with the beer.

Mr. Georgiadis stated that a lot of people had shown up that evening and he did not have sufficient staff on duty to cover.

Chair Shea stated that Mr. Georgiadis is responsible for his premises and needs to make sure he knows the rules for the liquor establishment.

Upon a motion the Commission voted 2-0 that violation had occurred.

Upon a motion the Commission voted 2-0 to issue a one day suspended suspension.

14. Electric Haze, 23 Millbury Street – Rule #1- Allowing patrons to remain on licensed premises after 2:00 a.m., Alcohol being consumed after hours, Manager Violation

**15**. M&S Entertainment dba Venue, 336 Main Street- Rule #14- Manager Violation, Rule #17-Alcohol taken from licensed premises, Rule #20 - Window Obstruction

Mohan Prashad appeared on behalf of violation and waived his right to counsel.

Lt. Johnson presented the following report:

On April 20, 2014 at around 1:21 a.m. officers assigned to the Bar Impact Unit called out with a possible fight/gun shots at the club Venue. Gang Unit and Bar Impact officers responded to the Venue to assist.

Officer Edward Saucier was assisting with other operations nearby and was able to respond within five minutes. Upon his arrival the club was pretty well cleared out and officers were still attempting to clear the street and sidewalk of club patrons. Detective Joe Ford advised Officer Saucier that he had observed a Hispanic male in his early 20's walk out the front door of the club with a bottle of Hennessy Cognac in his hand. The male walked by club staff and made no attempt to conceal the bottle of liquor. Detective Ford had attempted to stop the male but lost him in the crowd.

Officer Saucier entered the club to try and locate the manager but was informed by staff that he wasn't on the premises. Officer Saucier advised a staff bouncer what Detective Ford had observed and the bouncer stated they did sell a bottle of Hennessey at a VIP table but they lost track of things in all the pandemonium.

On April 20, 2014, one patron was arrested inside of the club and charged with assault and battery on a police officer, assault and battery with a dangerous weapon committed upon a police officer and resisting arrest.

It is believed the gun shots heard were actually a large metal door being slammed.

A responding officer's report states that Officer Solomon Obeng was working the detail assignment for Club Venue by himself and there were an estimated 150-200 people inside the club. The responding Officer was with Officer Johanson, stationed in front of Club Venue in a cruiser, when they heard two loud bangs and glass bottles shattering. The Officers could not see inside the club as the windows to the front of the club are completely tinted.

The officers began to approach the entrance way to the club and observed several patrons quickly exiting the club and two patrons informed the police that there were gun shots inside the club. The officers immediately radioed in that they were entering the club.

Once inside the club, the officers observed 10-15 males inside of the club fist fighting on the floor and Officer Obeng deployed OC Spray in an effort the quell the fight. After a short period of time, the OC spray began to take effect and the group of males stopped their behavior and began to exit the club.

One male, in particular, Jorge Cardoza, continued fighting and the officer observed that Jorge was continually punching an unidentified male, knocking him to the ground and kicked this male in his body with a shod foot. An officer grabbed onto Jorge's arms and he began to wildly throw punches at the officer and the club security guards. At the time, the floor was saturated from all the spilled drinks on the floor and the altercation ended up on the floor. While on the ground, Jorge repeatedly threw punches at the officer and kicked his shod feet at the officer.

Mr. Prashad stated that he was not there on the night in question as his cousin passed away but his sister and manager were there and a detail officer was present.

Mr. Prashad stated that at around 1:13 a.m. a few individuals came to the door and insisted on coming in and once they came in they got into an altercation with other patrons and the officer came in to assist.

With regards to the bottle of Hennessey sold, Mr. Prashad stated that they don't sell bottles and he could not explain how it got sold and he looked at his security cameras and didn't see anyone leaving with a bottle.

Lt. Johnson stated that the police need to be able to see into the establishment and they cannot. Mr. Prashad showed photographs taken at establishment showing that a person could see in. Lt. Johnson stated that those were taken during the day and at night one cannot see through the window.

The Commission suggested Mr. Prashad and Lt. Johnson meet that evening and they could discuss that matter and the Commission would not vote on Rule #20 until they heard back from the Lieutenant.

Upon a motion the Commission voted 2-0 that violation of Rule #14 and #17 did occur.

Upon a motion the Commission voted 2-0 to issue a two day suspended suspension.
