14. G Bar, LLC, dba G Bar, 62 Green Street – Violation of Rules #1, #14

After hours violation, manager responsible for premises violation

Hougseph Yaghmourian appeared to answer to the violation and waived his right to counsel.

Lt. Johnson presented the following:

On November 8, 2014, Officer Mark Jolin, Worcester Police Alcohol Enforcement Team, while driving down Green Street, at 2:10 a.m., noticed that the G Bar still had patrons inside the Licensed Premises.

Officer Jolin observed through the front window that the Licensed Premises appeared to be open, and he could see at least two people drinking from wine glasses.

Officer Jolin entered the Licensed Premises and observed approximately 8 people were sitting at the far end of the bar. He observed at least six glasses of wine on the bar and two of the people were actively drinking.

Officer Jolin recognized Garo Bekiarian, who is part owner of the Licensed Premises, and advised Mr. Bekiarian that the drinks must be removed and all patrons must leave the bar.

Mr. Bekiarian was very cooperative and removed the drinks and the patrons. Mr. Bekiarian was advised that he will have to appear before the License Commission to answer to the violations.

The Licensee is being charged with two violations of Rule #1, one for patrons inside the Licensed Premises after hours and the second for unconsumed beverages out after hours, and one Rule #14 manager violation.

Mr. Yaghmourian stated he had spoken to staff and incident like this will not happen again.

The Commission voted on roll call 3-0 that the violation had happened.

The Commission voted on a roll call to issue a warning.
