Paul Barber appeared on behalf of the item.

Commissioner Salvidio stated that the Commission would only take up the first two requests, June 5 and June 23, 2015 in order that Mr. Barber, the neighbors and city staff could meet prior to the next meeting to discuss the rest of the requests and see if an amicable agreement could be reached relative to the times of the events.

Mr. Barber stated that the June 5, 2015 event is for a charity fundraiser which will run from to 2:00 to 5:30 p.m.

Mr. Rolle stated that if the applicant is requesting to end at 5:30 then the Commission needs to discuss that and determine whether to amend hours to that.

Commissioner Salvidio stated that they would amend the June 5, 2015 application for the entertainment to be 2:00 to 5:30 p.m. and alcohol to be 2:00 to 6:00 p.m.

Upon a motion the Commission voted 3-0 to approve the June 5, 2015 alcohol and entertainment licenses with condition that entertainment be 2:00 to 5:30 p.m. and alcohol to be 2:00 p.m. to 6:00 p.m.

Mr. Barber stated that the June 23, 2015 event is for the Taste of Shrewsbury Street that has been going on for fifteen years and it is fundraiser for the merchant's association. Mr. Barber stated that he was one of originators of the Taste of Shrewsbury Street and they have always done entertainment outside and it is a great event.

The Commission reviewed the hours. Mr. Barber stated that last year the entertainment ended at 10:00 p.m. and they did lose sales compared to years before when they were allowed to go later and there is a lot of value to having that extra half hour.

Chair Shea stated that she sees that the City's recommendation was that it end at 9:00 p.m. and suggested due to the nature of the event that it be to 10:00 p.m.

Commissioner Salvidio stated that he would agree and 10:00 p.m. would be reasonable for everyone in neighborhood.

Chair Shea stated that she is excited about the event and thinks what was decided was fair.

Paul Giorgio, organizer for Taste of Shrewsbury, appeared on behalf of the event and stated that there have been no problems in the past 15 years of the event and is disappointed at the City's recommendation to condition it to end at 9:00 p.m. He stated that Shrewsbury Street is a vital commercial district in the city and if Worcester is going to be a hub of entertainment and expand its economic base then they shouldn't condition the approval to close that early.

Commissioner Salvidio stated that is why there is an independent board and they are making good progress in balancing the needs of the businesses and neighborhoods.

Mr. Rolle stated that the 9:00 p.m. recommendation was due to the fact that this was event was on a week night and also reminded people that there is only one meeting left in June for applicants' to apply if they want to do something outside of their regular entertainment license.

Upon a motion the Commission voted 3-0 to approve the June 23, 2015 alcohol and entertainment licenses with condition that entertainment be allowed from 4:00 p.m. - 10:00 p.m. and alcohol to be from 4:00 p.m. to 11:00 p.m.

Mr. Rolle asked if there were any other conditions that Commission wanted to place on the license. Chair Shea stated no.

Commissioner Salvidio asked what would be the hours. Mr. George stated that he hadn't thought of time but thought from 9:00 a.m. to 9:00 p.m. Lt. Johnson stated that the tables would need to be off the sidewalk by 9:00 p.m.

Upon a motion the Commission approved 3-0 to approve the sidewalk café to 9:00 p.m. and must adhere to the City of Worcester sidewalk dining rules.

Mr. Domenick stated that this is request for entertainment inside and outside.

Ms. Steele asked the Commission what hours were they approving for outside.

Mr. Domenick stated that he would like the outside area to go to midnight.

Commissioner Salvidio stated that given the area it could go later.

Commissioner Salvidio stated that it could go to 1:00 a.m.

Upon a motion the Commission voted 3-0 to approve the entertainment license for inside and outside to 1:00 a.m.

Other Business

14. St. Cyr, 235 Park Avenue – Parking lot conditions

Ms. Haralambous stated that in 1986 a condition was placed on the parking lot license for this location that arbor vitae along the Stavros property line remain and be maintained and that a six foot stockade fence be erected in front of arbor vitae's on the petitioner's property.

Erin Gavin stated that her mother Patricia Stavros lives next to the property and the fence has been put back but the arbor vitae's have not been replanted.

The Commission members discussed what would be the appropriate plantings to install.

Mrs. Stavros stated that she would like rhododendrons and it would be good if they were maintained.

Robert St. Cyr stated that he didn't realize how tight it is to pull out and doesn't understand why a fence and trees are required.

Mr. Rolle stated that the condition pre-dated the current zoning ordinance and the License Board at that time imposed that condition.

Commissioner Salvidio stated that in his dealings with the city that fencing as well as landscaping is required for parking lots and he like the two neighbors to work it out so the Commission doesn't have to set condition that 20 trees have to be put up as Commission understands the importance of greenspace.

The Commission after hearing from both sides agreed that rhododendrons will be planted.

Upon a motion the Commission voted 3-0 to amend the 1986 approval confirming that the fence be maintained that that by July 1, 2015 eight rhododendrons be planted and the site be maintained.
