Violation Hearings

7. Emerald Ale Corp. dba Belmont Liquors, 108 Belmont Street, Violation of Rules #6, #21, 204 CMR 2.05 – Sale to a minor

Madan Donepudi and Frank Jordan appeared on behalf of the violation.

Lt. James Johnson presented the following:

On June 27, 2015, Officers of the Worcester Police Department Alcohol Unit conducted compliance checks at various package stores throughout the city of Worcester. An underage male accompanied the officers and was instructed to enter a package store and attempt to purchase alcohol without providing identification.

At around 1:03 p.m., June 27, 2015, the underage male entered Belmont Liquors and purchased a six pack of Bud Light bottles for \$6.49 and was not given a receipt.

The male stated that a white male with glasses sold him the beer without asking for identification.

Sgt. Thomas Needham notified the clerk of the violation.

Mr. Jordan, the employee working the day of the violation, testified admitting that he made a bad judgement and sold to an underage person. Mr. Jordan further testified that they now check identifications for anyone buying alcohol who looks under 40. Chair Shea stated that they should be checking id's for everyone, not just those who look under 40.

Commissioner Shea stated that because this is the first violation for this owner and he is making changes he recommends a warning.

Based on the evidence, the Commission finds the Licensee violated Rules #6 and #21 of the Worcester License Commission Rules and Regulations for liquor licenses, a violation of 204 CMR 2.05 (2) relative to permitting an illegality on the licensed premises and a violation of M.G.L. c.138, § 34, on June 27, 2015 and imposed a warning.

Lt. James Johnson presented the following:

On June 27, 2015, Officers of the Worcester Police Department Alcohol Unit conducted compliance checks at various package stores throughout the city of Worcester. An underage female (identifying information held at the Worcester Police Station) accompanied the officers and was instructed to enter a package store and attempt to purchase alcohol without providing identification.

At around 3:04, the underage female entered the Licensed Premises and purchased a six pack of Bud Light bottles for \$7.50 and was not given a receipt. The female stated that an Asian female, wearing glasses, sold her the beer without asking for identification.

Sgt. Thomas Needham notified the clerk of the violation.

On June 27, 2015, Officers of the Worcester Police Department Alcohol Unit conducted compliance checks at various package stores throughout the city of Worcester. An underage male (identifying information held at the Worcester Police Station) accompanied the officers and was instructed to enter a package store and attempt to purchase alcohol without providing identification.

At around 2:44 p.m., the underage male entered the Licensed Premises and purchased a six pack of Bud Light bottles for \$7.50 and was not given a receipt. The male stated that an Asian female, wearing glasses, sold him the beer without asking for identification.

Sgt. Thomas Needham notified the clerk of the violation.

Ms. Prasahad stated that Ms. Tremoto was the clerk on duty that day and admitted that the violation had occurred and they have stepped up procedures for checking identifications.

Chair Shea stated that it is very concerning that it was two violations right after another on the same day and it is their obligation as the license holder to be vigilant and check identifications to make sure underage people are not served.

Commissioner Salvidio reminded Ms. Prasahad that the liquor license is a privilege and not a right and this establishment had come before the Commission last November for same violation. Now there were two more violations on the same day and he finds it troubling that the clerk did not ask for ID and sold the alcohol and thinks the establishment needs to step up and be more vigilant and take the business more seriously.

Commissioner Salvidio stated that the first time may have been mistake but when the Commission sees multiple violations then a pattern starts to develop that store is not following the rules.

Based on the evidence, the Commission finds the Licensee violated Rules #6 and #21 of the Worcester License Commission Rules and Regulations for liquor licenses, a violation of 204 CMR 2.05 (2) relative to permitting an illegality on the licensed premises and a violation of M.G.L. c.138, § 34, on June 27, 2015 and imposed a four day suspension. Two days suspended from the previous violation from last November and additional two for the violations that occurred on June 27, 2015.
