Lt. Johnson stated that the 1:00 a.m. condition has been imposed for the past three months and Sergeant Shawn Barbale who works the Bar Impact Unit will provide an update.

Sergeant Barbale stated that since the 1:00 a.m. closing that the area is much quieter and it much easier process to move people along in the area since the 1:00 a.m. condition was imposed.

Mr. Luna stated that there have been fights from other bars in the area and they are losing money and they are not profitable since the 1:00 a.m. closing was imposed.

Chair Salvidio stated that it seems that when this premises lets out at 2:00 a.m. that a large crowd leaves this premises all at the same time causing problems.

Commissioner Shea stated that the license holder provided financial detail that Commission requested at last meeting and what was provided was not acceptable as the figures were not certified.

Chair Salvidio stated that he would be inclined to move the time to 1:45 a.m. but this would be the last break the Commission is going to give to the establishment.

Upon a motion the Commission voted 2-0 to amend the hours of operation to the following,

- The Licensed Premises shall be 21 and older at all times.
- A police detail shall be required on Friday, Saturday and Sunday nights.
- Hours of operation are as follows:
 - o Wednesday closing time is 2:00 a.m.
 - o Thursday, Friday, Saturday closing time is 1:45 a.m.

- o Sunday closing time is 1:00 a.m.
- o Monday and Tuesday hours are 9:00 p.m. − 2:00 a.m.
- The licensee shall email the Police Department a list of upcoming events with expected occupancy one month in advance. The detail office will determine how many officers will be required.

Violation of Rule #14-Manager responsible for premises

Hiep Pham and Le Pham appeared to answer to the violation and waived their right to counsel.

Lt. Johnson reported that on August 7, 2017 Officer Edward Saucier and Officer Glenn Stout observed three suspicious looking bottles on a shelf behind the bar at the premises that were filled with a clear liquid and the bottom thirds of each bottle appeared to be full of a thicker "milky" substance and were all extremely sticky to the touch.

Officer Stout asked Hiep Pham, who identified himself as the manager, what was in the bottles who responded that the bottles contained alcohol and medicine and that he puts certain ingredients with the liquor and use it like medicine and that it primarily for his wife and does not serve to customers.

Le Pham stated that the sticky item on the bottle was garlic and is a cultural thing for the family and his parents did not know that they couldn't do that and it was only for the family use for medicinal/personal purposes and now they understand that they cannot do that it will not happen again.

Upon a roll call the Commission voted 2-0 that the violation had occurred.

Upon a roll call the Commission voted 2-0 to issue a warning.

V-3: Rhino Bites, Inc., dba Flying Rhino, 278 Shrewsbury Street

Violation of Rules #7, #14 – Sale to minor

Paul Barber appeared to answer to the violation and waived his right to counsel.

Lt. Johnson reported that on April 15, 2017 members of the Alcohol Enforcement Team were conducting compliance throughout the City of Worcester.

A nineteen year old male was instructed to enter the Licensed Premises and sit with an accompanying officer and sit at the bar area and attempt to order an alcoholic beverage without providing identification.

At 1:35 a.m. Officer Patrick Harrington and the underage male entered the Licensed Premises and both ordered a Bud Light. Both were served the Bud Light Bottles by a female bartender. Neither one was asked to provide identification.

Mr. Barber stated that the incident did happened and the bartender was reprimanded and since that time he has worked with his staff reviewing proper way to check identifications including having the Responsible Beverage Program which any new hire is taken through steps for responsible service. Also, all employees are TIPS certified and after this incident he went through all rules with his employees and at his last staff meeting he did role playing with his staff on different scenarios on ways people try to attempt to obtain alcohol who are underage.

Chair Salvidio stated that what Mr. Barber is doing is a good template of proper prevention procedures.

Upon a roll call the Commission voted 2-0 that the violation had occurred.

Upon a roll call the Commission voted 2-0 to issue a one day suspended suspension.
