Staff and Lt. Johnson reviewed the new rule which is as follows;

## AN AMENDMENT TO THE WORCESTER LICENSE COMMISSION RULES AND REGULATIONS RELATIVE TO THE TRAINING FOR DISPENSERS AND SELLERS OF ALCOHOLIC BEVERAGES

Be it adopted by the License Commission of the City of Worcester as follows:
Section 1. The City of Worcester License Commission Rules and Regulations for the Sale of Alcoholic Beverages to be Drunk on Premises is hereby amended by deleting Rule 28 in its entirety and inserting the following new Rule number 28:

Rule 28: Alcohol Server Training
(a) As of September 1, 2019, on-line computer alcohol server training courses will no longer be accepted. Managers and all persons involved in the sales of alcohol and serving of alcohol and/or viewing of identification cards shall be certified within thirty (30) calendar days of employment, except that persons serving under the authority of a one day special license shall be server trained prior to serving any alcoholic beverages. Proof of completion of an "in-class" /"live" alcohol server training program shall be submitted to the Worcester Police Department and the Department of Planning and Regulatory Services within thirty (30) days of employment.
(b) The following is a list of local in-class/live programs that are offered. This list is subject to change and may be updated at any time. The City does not endorse or support any specific program.

(c) All managers of licensed establishments must submit a copy of their certificate of completion of a live course to the Department of Planning \& Regulatory Services on an annual basis with the renewal application.
(d) All licensed establishments must maintain a record of employees who have completed a live course and have received a certificate at the Licensed Premises, in a place that is accessible. Said record of employees must be submitted annually to the Department of Planning and Regulatory Services with the renewal application.
(e) Employees must be re-certified once every three (3) years.
