Commissioner Vigliotti and Haller asked if Ms. Purdy was planning to do all the entertainment she had applied for. Ms. Purdy stated no. The Commission reviewed with Ms. Purdy the entertainment requested and amended request to include jukebox, TV, radio, dancing by patrons, amplification system, moving picture show, light show, theatrical exhibition, and karaoke, any other audio or visual show, whether or live recorded specifically.

Ms. Purdy stated that there is also a pool table at the location. Staff confirmed that a separate application would be need for that and that they would follow up with the applicant on that process.

V-1: Price Chopper, 72 Pullman Street

Request to temporarily remove condition of the use of ID scanners due to the coronavirus outbreak-

Lisa Durant from Price Chopper legal counsel appeared upon behalf of the item. Ms. Durant stated that due to the coronavirus outbreak Price Chopper would like to temporarily suspend the condition of their liquor license that all ID's must be run through the scanners which would limit the contact between customers and the cashiers.

Lt. Johnson and Attorney Kalkounis stated that ID's would still need to be checked for anyone that looked under 35 years of age and reviewed the acceptable forms of ID accepted in the state of Massachusetts and stated that the Worcester Police are not relaxing ID checking just temporally lifting restriction on use of scanner.

Commissioner Haller stated that she did not want the restriction to be lifted permanently and this would just be a temporary lifting on the condition and it was discussed with her fellow Commission members what did they think would be a good timeline. The members agreed that May 31 would be the timeline they would be willing to lift restriction, and if they have to re-visit prior to the expiration they would be willing to do so.

Upon a roll call vote the Commission voted 3-0 to temporarily suspend the requirement to scan ID through May 31 but the checking of all ID's according to Massachusetts General Laws is still a requirement.
