IV-1: TDMA LLC dba Diem Cannabis, 74 Grafton Street 30 day opening plan-

Attorney Michael Brangywyne and John Divolla appeared upon behalf of the item.

Mr. Brangywyne stated that they are awaiting for final inspection from the Canabis Commission and once that happens they will be set to open. He stated that they will be doing a grand opening but no soft opening. He stated that they will have 20-25 employees at first.

Commissioner Vigliotti asked where the parking would be located. Mr. Divolla stated that there are nine parking spots on site and that there is parking in the vicinity as well as the Union Station parking garage.

The Commission reviewed the conditions proposed by the Police and Law Department and the applicant stated that they were fine with the conditions as proposed.

Chair Shea stated that the Commission had reviewed the video the site sent in by the applicant.

Upon a roll call the Commission voted 3-0 to approve the 30 day opening plan with the following conditions;

- The hours of operation shall be 9am to 10pm Monday through Saturday and 10 am to 9 pm on Sundays.
- The Licensee shall provide no less than five (5) business days advanced written notice to the Worcester Police Department and the Division of Planning and Regulatory Services of the scheduled opening date for adult use sales.
- The 30 Day Opening Plan submitted to the Commission is hereby incorporated and made a condition of the License during the first thirty (30) days of operation with the following amendments under the section entitled "Police Detail":
 - 1. Delete paragraphs 1 and 2 and replace with the following: "Two police details shall be required for the opening date through the end of the weekend. This means if opening day is a Wednesday, 2 police details are required from Wednesday to Sunday."
 - 2. Subsequent to the first weekend of Operations after opening day the establishment shall one paid police detail officer during the following hours:
 - Monday- Friday 6pm-10pm
 - Saturday 9am-10pm
 - Sunday 10am-9pm
 - 3. The above detail requirement is subject to modification at any time during the first 30 days of operation by the Worcester Police Department as approved by the Commission.
 - 4. The Worcester Police Department shall work with Diem towards eliminating the above described police detail requirement as soon as it is reasonable and safe to do so, considering any parking, traffic or crowd concerns at the Premises

Must comply with all conditions of Special Permit issued by Planning Board

IV-2: Resinate, 1191 Millbury Street, 30 day opening plan-

Peter Decaro appeared upon behalf of the application. He stated that they opened the medicinal marijuana on March 21, and now they are waiting for final approval from the Canabis Commission for the retail portion of the site.

He stated that they will have 29 parking spots and that they will have an online ordering system as well as curb side pickup.

Chair Shea stated that the Commission had viewed the video of the premises sent in by the applicant.
