# <u>Alteration of Premises – Temporary Outdoor Dining (New)</u>

#### 2. OD-2020-048 The Fix, 106 Grove Street

Michael Covino called in for the item.

Proposal was as follows: Outdoor dining area, approximately 8'x86' in metered spots on east side of Grove Street, west of the building.42 seats with 14 tables. Hours of operation: Sunday–Wednesday: 4 PM–10 PM; Thursday–Saturday: 4 PM–11 PM.

Upon a roll call the Commission voted 3-0 to approve the temporary outdoor application.

#### 3. OD-2020-049 Dirt McGirt's, 1051 Main Street

Stacey Blanchette called in for the item.

Proposal was as follows: Tented outdoor dining area north of building. 24 seats with 4 tables. Hours of operation: Sunday–Wednesday: 11 AM–10 PM; Thursday–Saturday: 11 AM–11 PM.

Mr. Rolle asked Ms. Blanchette to review how people would access the parking lot.

Commissioner Haller requested Mr. Rolle review what the handicapped parking requirements would be for the site.

Upon a roll call the Commission voted 3-0 to approve the temporary outdoor dining application.

# 6. OD-2020-052 Wachusett Brewing Company, 152 Green Street

#### SW-2020-020 Sidewalk Dining License – Green Street/Kelley Sq.

Christian McMahan, Allen Fletcher and Domenic Mercurio called in for the item.

Proposal was as follows: Outdoor dining area on sidewalk on the northwest side of Harding Street, southeast of the building, and on the paved area abutting Kelley Square, south of the building. There will be a total of 125 seats with 25 tables (30 seats with 6 tables abutting Kelley Square and 95 seats with 19 tables on the Harding Street sidewalk). Tables will be equipped with patio umbrellas to protect patrons from the rain. Hours of operation: Monday–Wednesday: 11 AM–10 PM; Thursday–Saturday: 11 AM–11 PM.

Commissioner Haller asked Mr. Fletcher review how the food would be served into the outdoor area.

Upon a roll call the Commission voted 3-0 to approve the temporary outdoor dining application.

#### 7. OD-2020-053 Parkway Diner, 144-148 Shrewsbury Street

#### SW-2020-021 Sidewalk Dining License – Shrewsbury Street

Commissioner Vigliotti recused himself from item #7.

Proposal was as follows: Outdoor dining area on sidewalk on the northwest side of Shrewsbury Street, southeast of the building. 34 seats with 8 tables. Hours of operation: Sunday–Wednesday: 6 AM–10 PM; Thursday–Saturday: 6 AM–11 PM.

Upon a roll call the Commission voted 2-0 to approve the temporary outdoor dining application.

# 8. OD-2020-054 Pho Dakao, 593 Park Avenue

Hiep Pham called in for the item.

Proposal was as follows: Outdoor dining area enclosed by rope barrier to occupy four parking spaces in the parking lot northwest of the building. 18 seats with 6 tables with umbrellas to protect patrons from the weather. Hours of operation: 11 AM–10 PM daily.

Upon a roll call the Commission voted 3-0 to approve the temporary outdoor dining application.

#### 9. OD-2020-055 Stake's Club, 1281 Pleasant Street

Robert Stake called in for the item and reviewed the request along with the food planned to be served.

Proposal was as follows: Open-sided tented outdoor dining area enclosed by fencing as an extension of the existing patio in the parking lot north of the building. 36 seats. Hours of operation: Sunday–Wednesday: 2 PM–10 PM; Thursday–Saturday: 2 PM–11 PM with 8 tables.

Mr. Rolle asked Mr. Stake to describe out customers would get to the parking area. Mr. Stake state that he owns the building next door and there a separate driveway to access the parking at 1281 Pleasant Street.

Upon a roll call the Commission voted 3-0 to approve the temporary outdoor dining application.
