Attorney David L. Rubin and the Applicant, Nakula Patel called in for the item. Attorney Rubin stated that the applicant is seeking a beer and wine license for the 3,000 square foot convenience store.

Lt. James Johnson met the Applicant at the location of the proposed License and conducted a view, thereafter presenting the Commission with photos at the public hearing that were presented through a power point presentation and available for the public to see during the meeting.

Attorney Henry Levin, representing, AADYAC, LLC dba the Icebox, an existing package store located near the proposed license stated that his client is in opposition to the application and that the area is adequately served.

Commissioner Haller stated that based on the map provided by the Division of Planning & Regulatory Services, showing the existing Section 15 establishments in the area, she believes the area is already adequately served. Chairman Shea agreed with Commissioner Haller that the area is well served.

Commissioner Vigliotti stated that he also viewed the map and knows the area very well. He feels the area is adequately served. There are four (4) other licenses within one (1) mile of the proposed license.

In consideration of the discussion at the public hearings and upon a roll call, the Commission voted 3-0 to deny the application for a Section 15 malt & wine license at 1442 Grafton Street, finding the area is adequately served by the existing Section 15 off-premises establishments in the area.
