Upon a roll call the Commission voted 3-0 to approve the minutes of July 16, 2020.

#### New Business

#### Alteration of Premises – Temporary Outdoor Dining (New)

1. OD-2020-096The Pint, 56 Shrewsbury StreetSW-2020-044Sidewalk Dining – Shrewsbury Street

Marco Tonelli spoke upon behalf of the application.

He stated that he would like to put four (4) two side picnic tables outside his establishment. The food service would be pizza bagels, fruit dessert, salsa and he will add more food as he goes along.

Lt. Johnson stated that he was concerned that the tables be placed far enough away from Leo Turo Way, and stated he like them at least five feet in distance from Leo Turo Way.

Upon a roll call the Commission voted 3-0 to approve the temporary sidewalk dining request with following conditions:

Outdoor dining area in the public sidewalk on the north side of Shrewsbury Street, south of the building, 16 seats with 4 tables to be equipped with umbrellas to protect patrons from weather

Hours of operation: Sunday-Wednesday 5:00 PM-10:00 PM; Thursday-Saturday 5 PM-11 PM

## 2. OD-2020-097 Gallagher's Pub, 95A West Boylston Street

Applicant did not call in for meeting. Mr. Rolle reviewed the plans and food proposed for the site. The Commission requested Lt. Johnson go to the site in the next day or so to remind applicant that food needs to be served in outdoor dining area.

Upon a roll call the Commission voted 3-0 to approve the temporary outdoor dining request. House of operation: Monday–Sunday 11:00 AM–8:00 PM.

3. OD-2020-098 Café Neo, Inc., 97 Millbury Street
SW-2020-045 Sidewalk Dining – Millbury Street

Peter & Katie Tsigas called in for the meeting.

Lt. Johnson stated that he wanted stanchions put in between tables.

Upon a roll call the Commission voted 3-0 to approve the temporary outdoor dining request.
