- All events shall be scheduled with a planned end time before 11:00 PM, and except for baseball games and similar spectator sporting events, all events shall end by 11:00 PM.
- Any concert or event with an anticipated attendance of more than 500 patrons that includes onfield public access or seating is excluded from this permit, and will require a separate one-day entertainment license.
