Status hearing

A status hearing was held on the license as the License Commission and the Worcester Police Department had received complaints regarding noise, unruly patrons, neighborhood disturbances and reports of non-compliance with COVID-19 protocols.

Robert Ginisi called in for the item.

The Worcester Police provided a background of some of the complaints received and the Commission reviewed the emails they had received.

Neighbors of Biscuit Lofts adjacent to the premises stated that they have concerns about the noise and problems from the establishment but want to work with license holder to see if something can be done.

Mr. Ginisi stated that the back parking area is used by multiple license holders on the street so a lot of the complaints are coming from people leaving the parking area and not necessarily coming from his establishment.

The Commission asked Mr. Ginisi to meet with Lt. Johnson and review the concerns and asked Lt. Johnson to review police reports and bring the matter back to the Commission next week.
