Sgt. Needham presented the following;

On May 1, 2021, Officers of the Worcester Police Department Alcohol Unit conducted compliance checks at various package stores throughout the city of Worcester. An underage male accompanied the officers and was instructed to enter a package store and attempt to purchase alcohol without providing identification.

At around 11:59 a.m. the underage male entered Allstar Liquor, Inc. and purchased a six pack of Bud Light cans. The male was able to purchase the alcohol without being asked for identification.

Mr. Heer stated that he has owned the store for 16 years and apologized for what happened. He stated that this was a new employee and all his employees go through TIPS training and that in the past they have done the alcohol training course that the Worcester Police offer.

Mr. Pearlman stated that they were not contesting the facts as presented. Mr. Pearlman stated that they have reviewed the store operations and Friday and Saturdays, the day when this incident occurred, is when the store is the busiest so the owner of the store will operate the store on those two days.

The Commission noted that this was the first violation for the establishment.

34. Jian Hui Group Inc. dba Foodworks, 50 Southwest Cutoff

Violation of Rules #13, #14

Attorney Wei Jia along with Kevin Zhan and Meihua Chen participated remotely for the violation hearing.

A mandarin interpreter was present in the meeting room and provided translation services for people in the meeting and those participating remotely.

Sgt. Needham through the Mandarin interpreter presented the following report;

On February 5, 2021 a female entered Foodworks at 50 Southwest Cutoff at 8:30 p.m. and was delivered her first alcoholic drink, For the time span of 2 hours and 32 minutes the female consumed 4 ½ alcoholic drinks.

At 11:30 p.m. the female is seen on video attempting to stand up and almost knocking over all the drinks that were on the table she was seated at. As she proceeds toward the door she attempts to zip her jacket and she has difficulty zipping it and the male that was with her had to zip it for her and she is clearly swaying from side to side and has to be assisted out by her male friend.

On video it is observed that an employee of Foodworks cleaning a table in between where the female had been seated and the exit and watched her exit. The same employee is observed on video making a swaying motion to the female's friends as to be imitating her intoxication.

At approximately 11:33 p.m. the Worcester Police dispatch received a 911 call in regards to a single motor vehicle accident at 64 Southwest Cutoff. Investigation revealed that the operator was the same female who had just left Foodworks. She struck a bridge abutment at 64 Southwest Cutoff. She was the lone occupant in the vehicle and sustained serious bodily injury. During the course of the investigation it was determined that the operator's blood alcohol content was more than 2 times over the limit of .08. The blood alcohol was determined to be .17.

Mr. Jia thanked the Commission for having the translator available for the meeting thanked the Worcester Police Department for providing the video footage of the incident.

The Commission played the video provided by the Worcester Police Department.

Attorney Jia stated that they have to admit that what had happened was an unfortunate event but what is before the Commission is whether there is a violation of Rules #13 and #14 of the rules and regulations of the License Commission.

Attorney Jia stated that he had reviewed the video footage minute by minute and what the officer had reported is generally correct but there are some inaccuracies. Some are minor but some are critical. They admit that the female did have 5/12 drinks during the time frame. Two drinks were ordered by the female's friends and a 20:30 hours the police stated that the female is seen attempting to get up and spilling drinks but after watching the video footage several times that never happened. Also, the officer stated that there is no food ordered by this female patron but the footage shows female patron with her two friends and food was ordered by her friend.

Attorney Jia stated that according to the police report, at 22:47 hours it was the first time the woman shows the female being intoxicating as this is time when she got up to go to the bathroom. The report stated that she appeared somewhat unstable.

Attorney Jia stated that the female had been regular patron at restaurant for 3 years. She works at the 99 restaurant and comes to restaurant three to four times a week and she stays for 2-3 hours until closing hour and each of her visits she orders 3-4 mai tai's and she had never shown any problem with the 3-4 mai tai's on those previous visits.

Attorney Jei stated that the video presented was without audio but if had audio the Commission would have heard that the bartender was telling the female's friend to take her of her as she appeared intoxicated as she wasn't sure the male friend would take care of her.

Commissioner Vigliotti asked if the license holder had a bill that showed what was purchased. Mr. Zhang stated that he did. Commissioner Vigliotti asked if receipt showing any food purchased. Mr. Zhang stated no.

Attorney Jia stated that staff was assured by the female's male friend that they take care of her.

Upon a roll call vote the Commission voted 3-0 that the violation had occurred.

Upon a roll call vote the Commission voted 3-0 to issue a 60 day suspension. 40 of which will be served and 20 days suspended for one year.

On April 27, 2021 Officer Patrick Harrington and members of the Alcohol Enforcement Unit met with the owners, Robert Ginisi & Mark Kelly at the 4th and 1 LLC. At this time Mr. Ginisi was issued an official demand letter requesting documents & video pertaining to the operation of the premises. The letter requested that the information be provided to the Worcester Police by May 6, 2021 at 4:00 p.m.

May 6, 2021

On May 6, 2021 just after 4:00 p.m. Mr. Kelly went to the Worcester Police Department Headquarters and provided to Sergeant Thomas Needham and Office Harrington the following;

- Names and address of all employees working from October 1, 2020 to present.
- Copies of all employees TIPS certifications from October 1, 2021 to present.

Officer Harrington asked Mr. Kelly about the remaining employment information and Mr. Kelly stated that all staff at the 4th and 1 are volunteer members of the club.

Officer Harrington had also asked for copy of the video surveillance from the 4th and 1 LLC and Mr. Kelly stated that he was working on trying to get someone to download the requested video. Mr. Kelly could not provide any documentation that he has requested that from anyone.

As of July 14, 2021 the Worcester Police Alcohol United has not received the remaining documents or video.

Attorney Hector Pinero and Mark Kelly appeared in person to answer to the violation.

Attorney Pinero asked if the License Commission has a rule that that requires that a licensee have video surveillance. Sergeant Needham responded no.

Attorney Pinero asked Mr. Kelly if he had made attempts to provide the video information requested by the police. Mr. Kelly stated that he and Mr. Ginissee had tried but the current system at that time could only record for two days and they have been unable to retrieve the video information but they would be happy to connect with Sergeant Needham to see if there is a way that it could be retrieved.

Chairman Shea asked Mr. Kelly if when they were unable to retrieve the video did he contact the Worcester Police Department to tell them that. Mr. Kelly stated no but stated that since that time they have changed the video surveillance system. Mr. Kelly admitted that at beginning of their operation they didn't do a great job but now he and his partner are there on Friday and Saturday and there is doorman Friday/Saturday to ensure no one leaves the premises with drinks.

Attorney Pinero stated that he had called to Alcohol Beverage Control Commission and asked Kyle Gill about whether rule requiring license holders provide video. Mr. Gill stated that each municipality free to adopt to rule to video but Worcester does not currently have one should the license holder should not be sanctioned for that.

Chairman Shea stated that the police are the enforcement for the License Commission and has the right to ask for items that pertinent to their investigation.

Attorney Pinero stated that with regard to violation that the license holder not providing info on members W-2's that the staff are volunteers who work for TIPS so there are no W-9's.

Upon a roll call vote the Commission voted 3-0 that the violation occurred.

Upon a roll call vote the Commission voted 3-0 to issue a one day suspended suspension.
