Commissioner Haller explained to Attorney Mourad that they only have a two member Board today and he can ask to continue item until there is full Board.

Commissioner Haller stated that she feel that the area is well served and that if this is granted that more traffic would be generated.

Attorney Mourad stated that they don't see there would be an increase in traffic if the license is granted.

Commissioner Haller stated that if he like to continue the item she would recommend a plan on how station would be staffed as when Commissioners viewed the premises this morning staff left the store to pump gas for customer which left the store unattended.

Public Comment

Mike Faucher, Wachusett Wine and Spirits, spoke in opposition to the application stating that the area is already adequately served.

Upon a roll call vote the Commission voted 2-0 to continue the application to the March 10, 2022 License Commission meeting.
