## Call to Order: 10:30 a.m.

On September 15, 2022 at 10:30 a.m. in the Esther Howland Chambers, 3<sup>rd</sup> floor, City Hall the City of Worcester and the Massachusetts Alcoholic Beverages Control Commission (ABCC) are hosting an outreach seminar in Worcester to help licensees maintain compliance and be successful in their business.

## **Topics will include**

## A. Changes to an existing license:

- Ownership
- New Officers/Directors/Trustees
- Change of the Description of Premises (Abutter notification requirement)
- Change of Manager
- Change of Hours (Including Sundays)

## B. Outdoor patios and seating:

- Adding patios/outdoor seating areas requires an alteration of premises application.
- Alcohol cannot be served on any patios until approved by the LLA, ABCC and there is an amended license issued with new description. (Legal Update- April 1, 2023)
- It is the Licensee's responsibility to maintain control of the outside premises (Supervision and Access).

## C. Purchasing of alcohol from authorized sources.

• Restaurants, clubs, and package stores cannot purchase any alcohol from package stores, big box stores and/or out of state entities.

## D. Section 12 and 15 licensees with same ownership entity.

• Alcohol cannot be transferred between licenses. Each license is their own business. If this action occurs, the licensee is acting as a Wholesaler and this is a violation.

## E. Delivery of alcohol:

- Only allowed for a section 15 licensee w/a section 22 transportation permit.
- Section 12 licensees are allowed to sell alcohol to go until at least April 1, 2023.
- Sale and delivery of alcohol extends to the front door of home where alcohol is being delivered too.
- Verifying legal age and checking of ID is the responsibility of the licensee and licensee representative (delivery person) at the time of delivery.

## F/G. Importance of checking ID's:

- 6-Types of acceptable forms of ID
- Monitoring of groups consisting of legal individuals and underage individuals on the licensed premises.

# H. MGL Chapter 90 Section 24J OUI Conviction "Last place of drink".

- I. <u>Hours of operations:</u>
  - Last call and vacate of licensed premises procedures.
- J. <u>LLA and ABCC right to inspect the licensed premises.</u>
- K. Age that an individual can serve alcohol.
  - <u>18 Years of age and older can serve and handle alcohol in the course of their employment.</u>
- L. <u>Club Licenses: For Members and Guests of Members (Not open to the public)</u>
- M. <u>Annual license renewals must be submitted to the Worcester Board no later than</u> <u>11/30/2022</u>
