At approximately 9:20 a.m. the Chair entertained a motion to convene in executive session pursuant to M.G.L c. 30A. §21(a) (1) and 21(a) (3) to conduct disability hearings and discuss litigation strategy regarding pending cases. The Board will not reconvene in open session following the executive session. The motion was moved and on a unanimous roll call vote the Board went into executive session.

At approximately 11:30 a.m. the Board reconvened in open session to handle the 91A issue of WM Gardiner. After hearing from Mr. Gardiner, the board agreed to grant him an extension until next meeting on January 11, 2018 and ask PERAC if we have discretion for further extensions. The Board Chair offered suggestions to address Mr. Gardiner's problem with his accountant and offered they speak directly with the accountant. The Board will ask PERAC if it can be extended for 60 days.

The Board voted to request an extension form PERAC for a 60 day stay of suspension to complete filing requirements after reviewing financial documentation. Unanimous.
