The Board convened in executive session pursuant to M.G.L. c. 30A, § 21(a)(1) and 21(a)(3) to conduct disability hearings and discuss litigation strategy regarding pending cases at approximately 8:45 a.m. by roll call vote and will reconvene in open public session immediately following the executive session.

The Board reconvened in open session at approximately 9:45 a.m.

The Board filed the October C/R & C/D, Custodial Report YTD November 2018 Office Budget, and Trial Balance following a review by R. Stearns.

Legal RFP responses were discussed. A compilation of the Board members evaluation sheets was provided. Based on that as well as content of the RFP the Board voted unanimously to hire the Law Offices of Michael Sacco for the next 3 years with two 2year extensions pending PERAC approval.

PERAC informed the Board that the following individuals: Thomas Fennell, William Gardiner, and Michelle Sargent failed to report 2017 earnings as required under section 91 A. They were notified of their right to attend this Board meeting for a hearing prior to suspension of disability benefits. Since sending out notice Thomas Fennell has complied and William Gardiner is working to comply. Michelle Sargent has not contacted the office or PERAC. A final certified letter will be sent to her. If she is not in compliance the Board voted unanimously to suspend effective her pension commencing with the 12/31 payment.

The Meeting Schedule for 2019 was provided to the Board.

The Board briefly discussed the RFP responses for Custody and Medical Review Services. R. Stearns and E. Early with meet with all respondents for the Custody and will bring back a recommendation for the next meeting and potentially finalists. E Early to seek further information from the UMASS group that responded to the Medical Review Services RFP. Potential to retain both was discussed.
