## 1. Call to Order and Introductions at 5:47pm

## 2. Review of minutes January 3<sup>rd</sup>, 2017

Chairperson Maddox requested to amend replacing First Aid with Mental Health First Aid on the bottom of the first page. Jennifer Madson motioned to approve the minutes as amended. Amanda Gregoire seconded. Unanimously approved as amended.

### 3. New Business:

### A. Discuss Equal Pay Day/Women's Economic Literacy Event

Amanda Gregoire informed the Committee that the trainer from Merrill Lynch is not available to provide a workshop on Equal Pay Day, April 4, 2017. Director Turchek recommended that the event be held later in April, with a Mayoral Proclamation the week of Equal Pay Day to announce the event. Amanda Gregoire will reach out to Merrill Lynch to schedule this event. The Committee members discussed requirements for the event venue. The Committee agreed that the event be held in an accessible, private, locally and womanowned business.

### 4. Old Business- Discussion:

### A. Review of mental health campaign

Chair Maddox informed the Committee that she spoke with Dr. Travis from the Division of Public Health and relayed information about the current projects being undertaken as part of the mental health campaign. Chair suggested that the Committee be a leader on this campaign, with a special emphasis on the Collaborative Care Model and Community forum. The Committee expressed interest in pursuing this initiative, given that the Community Health Initiative Plan (CHIP) runs until 2020. Donna Connolly motioned that the Committee take the lead on the forum going forward. Jennifer Madson seconded. Unanimously approved. The Committee will discuss next steps at the next meeting.





# B. Update on planning for 2017 International Women's Day (March 8<sup>th</sup>)

Deb Hall clarified that due to a scheduling conflict with Attorney General Maura Healy, the event will now be held on March 7<sup>th</sup>, 5:00-7:00PM. The next planning meeting will be on February 8<sup>th</sup> at 9:30AM at the YWCA, in the Boardroom. Deb Hall asked Director Turchek if the Committee ought to solicit vendors for the event, and whether or not the Committee had its own budget. The Director advised that the Committee not to solicit vendors and suggested the Committee serve more to assist with promoting event. Jennifer Madson proposed that the Committee meet on Tuesday, March 14<sup>th</sup>, 2017 at 6:00PM in the Levi Lincoln Chamber, as the event on March 7<sup>th</sup> would conflict with the Committee's next meeting. The Committee agreed.
