**EXECUTIVE SESSION:** The Board recessed to Executive Session to discuss litigation and returned at 5:45 P.M.

**27-39 Waldo Street – Special Permits:** Upon a motion by Thomas Hannigan and seconded by Amar Kapur, the Board voted unanimously to approve the requested Special Permits.

**1 Tiverton Parkway – Special Permit:** Upon a motion by Amar Kapur and seconded by John Reynolds, the Board voted unanimously to approve the requested Special Permit.
