John Barbale, Chairman, opened the meeting at 5:30 P.M. The following actions were taken:

- **31 Rollinson Road -- Variance:** Upon a motion by John Reynolds and seconded by Jerry Horton, the Board voted 5-0 to approve the requested Leave to Withdraw Without Prejudice.
- 12 Hollywood Street Special Permits and Variances: Upon a motion by John Reynolds and seconded by Jerry Horton, the Board voted 5-0 to deny the requested Special Permits for: 1) new residential construction or conversion to additional dwelling units (2 additional units in basement of three-family); and 2) expansion or change of a non-conforming use and Variances for: 1) relief of 5,000 square feet from Gross Dimensional requirement; 2) relief of 20 feet from Frontage requirement; and 3) relief of eight spaces from off-street parking requirement.
- **4 Lowell Street Special Permits and Variances:** Upon a motion by John Reynolds and seconded by Matthew Armendo, the Board voted 5-0 to continue the hearing to December 1, 2003.
- **6 Pullman Street Special Permit:** Upon a motion by John Reynolds and seconded by Matthew Armendo, the Board voted 5-0 to continue the hearing to January 26, 2004. (Reports from Fire Dept. and Health Dept. needed).
- **15-23 Eastern Avenue Special Permit:** Upon a motion by John Reynolds and seconded by Jerry Horton, the Board voted 5-0 to approve the requested Special Permit to allow a professional office building (medical) in RG-5 district with the following conditions: 1) restricted to endoscopies; 2) no abortion or gynecological clinics; 3) exterior air handling on roof of building; and 4) hours of operation restricted to 7:00 a.m. to 6:00 p.m. only.

- **31 Houghton Street Special Permit:** Upon a motion by John Reynolds and seconded by Jerry Horton, the Board voted 5-0 to approve the requested Special Permit for conversion of additional dwelling units (convert two-family to three-family).
- **32 Sears Island Drive Special Permit and Variance:** Upon a motion by John Reynolds and seconded by Jerry Horton, the Board voted 5-0 to approve the requested Special Permit to construct addition to existing single-family dwelling and Variance for relief of one (1) foot from Side Yard setback requirements.
- **373 Shrewsbury Street Special Permit and Variance:** Upon a motion by Thomas Hannigan and seconded by John Reynolds, the Board voted 5-0 to approve the requested Special Permit to allow personal service (hair/nail day spa) in a MG-2 district and Variance for relief of four (4) spaces from off-street parking requirements.
- **452 Lake Avenue Variances:** Upon a motion by John Reynolds and seconded by Jerry Horton, the Board voted 5-0 to approve the requested Leave to Withdraw Without Prejudice.
- **525 Lincoln Street Variance:** Upon a motion by John Reynolds and seconded by Jerry Horton, the Board voted 5-0 to approve the requested Variance for 40 square feet of relief from Gross Dimensional requirements.
- **65 Moreland Green Drive -- Variance:** Upon a motion by John Reynolds and seconded by Jerry Horton, the Board voted 5-0 to approve the requested Variance for eight (8) feet of relief from Article IV, Section 8 (II)(J) requirements. Proposed garage roof to exceed allowable "accessory building" height of 15 feet.
- **812 Franklin Street Special Permits:** Upon a motion by John Reynolds and seconded by Jerry Horton, the Board voted 5-0 to continue the hearing to December 15, 2003.
