 - **Videos:** The first video is on hold as staff has been asked to revisit and rework the video with the help of the City's new Marketing Director.
 - Youth Ambassadors: The group discussed the idea of developing a team of youth ambassadors funded through a stipend from the Youth Opportunities Office. The group discussed various elements of this project. Action: J. Turgeon and S. McGauley to research other youth ambassador programs and contact Kathy Hamilton from the Boston PIC about her experiences with a youth outreach program.
 - **Future of meetings:** After some discussion, the group agreed to move the meetings to the second Tuesday of every other month at 3:00PM.
